Parish of Saint George Minutes of the Annual General Meeting February 28, 2016

A. OPENING PRAYER: Fr. Snook opened in prayer.

MOTION: C. Savoury moved that Fr Snook chair the meeting. T. Lenfesty seconded. Carried.

B. MINUTES: Minutes of the meeting of the St George's Annual General Meeting, February 22, 2015, were circulated.

MOTION: J.M. Dawson moved that the minutes be adopted. J. de Mestral seconded. Carried.

C. BUSINESS ARISING

Daniel Watson's concerns regarding usury and parish finances

Al Wilson mentioned that these concerns were brought to the Spiritual Development committee. Fr Christopher said that Spiritual Development is meeting on this and hopes to create study groups or possibly a lecture series on the issues Daniel raises.

D. CORRESPONDENCE

None.

E. REPORT OF THE RECTOR

Fr Christopher encouraged us to take the 'hiddenness' of our lives together to help carry one another's burdens and to step into the life of this neighbourhood in more explicit ways. He gave thanks to God for the labour of so many who labour at St George's, many without recognition. He called especial thanks to the work of Gwynedd Pickett, who is finishing her term as Warden. He also gave thanks to God for Craig's time as Warden, as Craig makes a lateral movement to the position of Chair of the Property Committee.

MOTION: J. Connors moved the acceptance of the Rector's Report. S. Armstrong seconded. Carried.

F. WARDENS' REPORT

Gwynedd called attention to the written report, and urged that those who are interested in helping with various property things should be in touch with Craig Savoury.

Safer Church

Work on this continues. Although we are a little behind schedule, that doesn't seem to be out of step with most other parishes in the diocese, and we are pleased wit the work that has taken place so far.

J. Connors thanked Gwynedd for her time, and remarked on how lucky we are at St George's to have a number of people willing to step up to be Warden. Serving as Warden means one sees the inner workings of St George's firsthand, and it is a great perspective for many different people to experience.

MOTION: G. Pickett moved the acceptance of the Wardens' Report. K. Diamond seconded. Carried.

G. FINANCIAL STATEMENTS FOR 2015

Parish Finances

We finished 2015 with a small surplus — a wonderful turnaround from our fear several months ago of a deficit approaching \$60,000!

We budgeted for the same amount of undesignated offerings as we have budgeted for the last several years, but we again did not meet it. We were helped in our expenses by low oil prices and a mild fall and early winter, saving us on heating costs.

Friends of St George's Society contributed \$50,400 to expenses, including the Rector's Stipend, Office Manager's Stipend, and the Music Director's Stipend.

Total income - \$303,469.00 Total expenses - 302,031.00 Net income - 1,438

MOTION: J. Connors moved the acceptance of the unaudited financial statements. M. Hills seconded. Carried.

J. Connors mentioned that we have a number of funds invested through the Diocese, and there is a task group formed at the Diocesan level that is looking into assessing the ethical nature of where such money is invested, which has also been of interest to members of the congregation.

Deck the Hall Finances

The income for Deck the Hall in 2015 was \$202,536.95. The new large windows in the main hall came in under budget at \$79,797.03, and we will soon be spending the bulk of the money fundraised so far on renovations in the Music Room and basement, meaning more fundraising will need to be done for the next part of the renovation plan.

J. M. Dawson thanked Jan for her hard work on the Financial Statements this year and years previous. Many hours go into this work, and she handles all the details beautifully.

H. INSURANCE REPORTS FOR 2015

No claim has been made.

I. REPORTS OF THE STANDING COMMITTEES

With Craig Savoury taking over the role of Property Chair, A. Wilson thanked Jens Jensen for his long work as Chair for many years, often alone. He also mentioned that even without Deck the Hall, there is a tremendous amount of work to be done to keep the hall and church buildings clean and in good repair. He put his faith and hope in Craig's knowledge, and pointed out that though much of us spend more time in the church buildings, the real work of the parish takes place in the hall.

MOTION: S. Harris moved the adoption of the Standing Committee reports as circulated. S. Parker Nicolle seconded. Carried.

J. BUDGET FOR 2016

This year we looked at the average undesignated offerings for three recent years, giving us \$218,500, then assessed other areas that we knew we could expect. We also asked Friends of St George's if they could increase their monthly amount contributing on behalf of the Parish from \$4,200 to \$4,500 per month. They have agreed to meet this. We found that we were still \$37,000 short of balancing our budget.

The Budget committee put a great deal of thought and discussion into this. We wondered if there were other sources of support we could seek, especially for things like the Soup Kitchen or Deaf Ministry. We are also rejuvenating the Stewardship Committee. This need to source other income is reflected in the budget with line 10: "Other Source of Program Fund Raising."

G. Pickett asked why the line for Elisabeth Stones's payroll seemed so low. J Connors confirmed that, due to the many different duties of the Parish Administrator, much of the office manager's salary falls under "Soup Kitchen Coordinator/Outreach Support."

A. Lee asked which line item would cover the Safer Church police checks for Sunday School teachers. It was confirmed that the costs wouldn't come out of the Sunday School supply budget.

MOTION: J. Connors moved the proposed balanced budget be approved. J.M. Dawson seconded. Carried.

K. ELECTIONS

S. Armstrong asked what the length of the terms for the new Wardens would be, as we are electing two new Wardens at the same time — would one take on a two-year term and the other a three-year term? It was determined that this would be decided among the Wardens.

MOTION: C. Savoury moved that the position of Parish Wardens be voted on in block. S Armstrong seconded. Carried.

MOTION: Sue Zinck and Jacquie de Mestral were nominated as Parish Wardens. Fr Christopher asked three times if there were any further nominations for the position of Parish Warden. None were forthcoming. Carried.

MOTION: Rozzi Curran, Richard Kent, and Jennifer King were nominated as Members-at-Large on Parish Council. Fr Christopher asked three times if there were any further nominations for Members-at-Large. None were forthcoming. Carried.

The following were nominated to non-Parish Council positions: Patricia Martinson - Diocesan Times, Susan Dodd - Outreach Chair, Jane Mills - Stewardship

Committee, Nathan McAllister - Finance Committee Chair, and Craig Savoury - Property Committee Chair.

L. ANY OTHER BUSINESS

W. Shaw would like to officially donate to the Parish Library a book he has written on coping with authority, something which is made difficult due to selfishness and pride leading one to want to be independent of rather than subject to lawful authority.

T. Urquhart, Parish Librarian, received the book on behalf of the Parish.

J. de Mestral called our attention to the upcoming Parish Quiet Day, led by friend of the Parish, the Rev'd Nicholas Hatt.

M. CLOSING PRAYER: Fr Christopher closed the meeting in prayer.

Report of the Priest-in-Charge

To the Wardens and Members of Parish Council and Parishioners:

At the beginning of September, I was asked by the Bishop if I would be willing to be Priest-in-Charge of St. George's Parish while the rector went on Sick Leave. The people of St. George's have been so welcoming over the past 11 years and I am only pleased to be able to be of some help again. This report is for the four months from September until the end of December, 2016.

I wish to acknowledge the wonderful assistance I have received from Father Peter Harris. Fr. Peter took on the task of scheduling the Deacons' Roster for the Sunday Eucharists, and from time to time he and I have switched duties between being the Celebrant at the Eucharist or the Deacon. I know he will be of great help to Fr. Snook when he returns.

Elisabeth Stones resigned as Parish Administrator at the end of Summer, and Jordan Gracie was hired to take her place. The work of the Parish Administrator is quite the plate-full, and Jordan seems to be fitting in quite well. He has quite the knowledge of the "workings" of St. George's.

The Wardens and Parish Council have stepped up to the plate and with tremendous dedication and enthusiasm have made sure the spiritual and administrative life of the Parish continues on as usual with the Rector's absence. As you will see from the Wardens' Report, Council has been busy and a great deal has taken place. My sincere thanks to our Parish Wardens, Al Wilson, Sue Zinck, and Jacquie de Mestral and the Members of Parish Council for carrying out their responsibilities so admirably.

Much work was carried out on the exterior of the Church and Parish Hall, with painting, replacing of shingles and trim, as well as more windows replaced in the Parish Hall. The paving of the Parking Lot has greatly enhanced the beauty of the property, not to mention the care taken in the lawns and gardens. Our thanks and appreciation to Roger and his staff for the dedication they take in maintaining the Church property. Jim Rawding quietly goes about his work each week cleaning the interior of the Church and making it ready for Sunday worship. The cleanliness and beauty of the Church Property is a reflection of the faith and love of God the Congregation has.

The faith and love of God is also reflected in the worship at St. George's. It begins with the dedication of the Altar Guild preparing the altar, the Brass Polishers, the printing of the Sunday Bulletin, Greeters, Servers and Ministers of the Sanctuary and the magnificent music led by our Organist, Garth MacPhee and the Choir Members, as well as the full participation of the Congregation. How fortunate we are to have such talented and dedicated people to lift our spirits to the heavenly realm, and leave us knowing we have been in the presence of God. The Advent Lessons & Carols Service and the Christmas Services were well attended and added so much to our Christmas Celebration.

Regarding worship at St. George's, I did mention to Parish Council that it was disappointing to see so few people out for Choral Evensong to commemorate Remembrance Day. I suggested that holding this event AFTER Remembrance Day may be a reason for the low attendance - for most people, Remembrance ends at the Cenotaph Service on Nov. 11th. So the Sunday before might work better. I also suggested that perhaps they could look at celebrating Remembrance at the main Service on Sunday at 10:30am when the greatest number of worshipers are present. I simply offer this as a suggestion in planning the service for 2017.

A lot goes on at St. George's with many people behind the scenes: Sunday School, YouthNet, Scouts, Soup Kitchen, Coffee Hour (both Sundays & Wednesdays), Counters, Envelope Secretary, Librarian, Archivist, Deck the Hall, Church and Hall cleaners, Halifax Humanities, Sextons, and others. Without you the Ministry of St. George's within the Parish and in the wider Community just wouldn't take place. Thank you for your dedication. In September Tracy vom Hangen died and her Requiem was held on Sunday, September 18th in the afternoon. The Church was filled with many of her friends and colleagues from Acadia University and elsewhere. Because our Hall was rented out, St. Patrick's Church was most gracious in offering their Hall for the reception and we are most grateful. Despite her many trips to the hospital, Tracy was a faithful Parishioner and a very remarkable woman.

Rest eternal grant unto her, O Lord, and let light perpetual shine upon her.

Report of the Pastoral Visitor

To the Wardens and Members of Parish Council and Parishioners:

Once again, it has been my joy and privilege to share in the Ministry at St. George's as part-time **Pastoral Visitor** for the year 2016. This Report covers the period from January 1, 2016 - September 4, 2016. On September 5, 2016, I was asked to be **Priest-in-Charge** while Father Snook went on sick leave. The report covering September 5, 2016 - December 31, 2016 precedes this one.

My Ministry as Pastoral Visitor is to assist Fr. Snook in the Pastoral Ministry of the Parish so that he may also have time for the other responsibilities that come his way as well.

This part-time Ministry involves hospital visits, Home and Hospital Communions, and occasionally Celebrating the Eucharist at St. George's, assisting as Deacon, and Preaching. I have also assisted at Funerals.

I have been "on-call" occasionally while the Rector has been able to have a day off with his family, and also during holiday time.

I continue to extend an invitation to the other Anglican residents at the Evergreen Home for Special Care in Kentville, when I am there to celebrate the Holy Communion with Ken Pringle. We average around 6-8 on each visit.

At the end of May, Shirley Miles died quite suddenly and unexpectedly. I was able to be with Fred and his family at the Funeral Home to view the body before cremation, and to have prayers with them, as well as assist Fr. Snook during the Funeral.

This year saw the death of Grace Burfitt, one of my ling-time Nursing Home Communicants. I visited her quite regularly at Melville Lodge, she had been a former member of the Cathedral and sang in the Choir for many years, and so her Funeral was held at the Cathedral Church of All Saints on August 27. While the Rector was away on holiday in August, Heather Jensen died after being admitted to hospital a week earlier. Heather was a faithful Parishioner of St. George's and served on a number of committees, including Parish Council. Jens, Heather and I had Communion together and Heather was Anointed. I celebrated her Requiem at St. George's on August 27. *"Rest eternal grant unto them, O Lord, and let light perpetual shine upon them."*

I thank you for the opportunity to exercise this Ministry and to be a part of the life of St. George's.

Report of the Wardens

From Diocesan Canon 35, on Wardens:

"encouraging mutual responsibility in fulfilling the total ministry to the community"

Another year has passed in the Parish of St George. And like years past, it was a busy year.

I do not wish to "steal the thunder" of the various committee chairs and other leaders from within the parish. However, I do feel it necessary to recognize the remarkable talents and great giving of self made by our brothers and sisters, both of the parish and friends of the parish. I offer my apologies for those worthy activities which I have forgotten – they are no less worthy of recognition and thanksgiving. I can only offer my thanks to those who make these, and other works go on in our parish.

Spiritual and Sacred Art series during both Lent and Advent, organized by Stephen Gibson.

A six week discussion group on Chris Armstrong's book , Medieval Wisdom for Modern Christians, led by Stan and Barb Armstrong.

Neil Roberson's usury series.

Quiet day led by the Rev'd Nicholas Hatt

Tremendous performances by our choir members in addition to the many choral services; Handel's Dixit Dominus concert, several Helios concerts, and others.

Our music program over all, adult & junior choirs, and the "Cherubs".

The Tea at Trinity series.

The continued work of Youth Net.

Soup Kitchen, and the work of all of the volunteers that go into that program, not only preparing and providing a meal, but extending a hand to those who need it more than most.

The fellowship teams.

Christmas outreach to our neighbourhood families.

The deaf community and ministry.

Other items of note from the past year, in no particular order:

The growing community of Trinity House.

Opportunities in the past year to grow spiritually in our human community: series on relationship to money (mentioned above), safety in community when reviewing the Safer Church requirements, offerings and our mission.

The departure of Elisabeth as our Parish Administrator.

The arrival of Jordan as our Parish Administrator (who hit the ground running).

Father Snook's medical leave from September onward.

Father Purchase's continued spiritual and liturgical leadership and guidance, including reaching his 10th anniversary at St. George's at the end of the year.

The deficit of the last year.

CRA audit.

Reworking the cleaning regime for the hall, including the appointment of Jordan as our "5S" Coordinator.

Closer ties with St. Patrick's across the road, through the Refugee Sponsorship Committee, the use of their hall, Palm Sunday, and other collaborations.

A great deal of work done to parish buildings, including parking lot paving, repairs and improvements to the church building and front retaining wall, continued work on the hall including the major work done to the music space and the hall exterior, improvements to communications infrastructure, and others.

I would comment on a couple of these points. Fr. Snook's absence can be approached in a number of ways. I am reminded of a time when Fr. Gary Thorne, a previous rector of the parish, was absent in order to minister to others as an army chaplain with the United Nations in the Golan. I am reminded of this because it happened to be the time in which my Meghan and myself were married by Fr. Neish in the parish. The Rector was absent, but God, and the rest of us, remained. All was well. The parish went on.

From my point of view, this is largely due to the very nature of St. George's – the holding to a common means of worship and liturgy in the Book of Common Prayer, the special nature of our shared approach to liturgy, and out understanding of how scripture shapes our common life together, and our commitment to God's creation in our mission and outreach. These are the ties that bind us together, as gifts freely offered by God. A second thought that arises from this time comes from a letter from Fr. Thorne after he was hospitalized during his duty in the Golan. While the exact words escape me, he stated something to the effect that he offered thanks to God for the opportunity to meet those in hospital with him, whom he otherwise would likely not have had the chance to meet. In this I take the lesson that, rather than lament his absence, we ought to look for the opportunities presented in Fr. Snook's absence. The wardens took this time of opportunity to balance the administrative load of the parish. Over time, the position of Rector has taken on more and more of an administrative load. This has been largely corrected, out of necessity if nothing else. It is our intention to maintain a better balance on Fr. Snook's return.

Other initiatives of the wardens included reviewing parish contracts such as those for cleaning supplies and services, rental policies for the parish buildings, parking policy, and others. The wardens also set about to re-invigorate our various committees, both by encouraging parishioners to look at joining a committee, and by empowering and encouraging our various chairs and other leaders in the exercise of their various positions. I would use the Property Committee as an example. It went from no one, to having a chair, to now, where there are several members actively engaged in excellent stewardship of the parish buildings and properties. We shall continue to help committees where needed, and encourage those which continue to do the good work that they do on all of our behalf.

The past is only half of the story. As we look forward to the future, challenges await us all. We must adapt the parish to realities of reduced financial resources. The CRA audit will require some study and changes to ensure compliance. Other items will place a burden upon us all. But please do remember, His burden is light. There are good things on the horizon: restoration to some of our church windows, continued educational pieces, music, our liturgy, and our common worship. Through our lifting up of each other, we can and will continue to grow in Christ. I would hold up the committee chairs, committee members, mission volunteers, our Music Director, choir members, the donors and workers doing so much work to our parish buildings and grounds, and all of you and your support to and for the wardens this past year in praise and thanksgiving. Thank you all.

I would like to give an offer of personal thanks:

Fr. Jim – words cannot express what a blessing you have been to us.

Jan Connors – for your tireless work on behalf of the Wardens and the parish as a whole.

My fellow wardens – without whom I would have failed.

In closing, I have two final thoughts. One, I am heartened to see that we continue to grow as a parish, and that indeed many of us have stepped forward in our mutual responsibility of total ministry. So many of you have come forward when called. For this I am truly thankful. Second, I look forward to the return of our Rector, and serving with him in the call that draws us all to Saint George's.

Reports from Committees, Subcommittees, Parish Organizations, and Congregational Bodies

Report of the Spiritual Development Committee

In 2016, the Spiritual Development Christian Education group met twice to discuss possible educational programmes for the parish throughout the year and the group which attends to the preparations for Holy Week/Easter and Advent/Christmas met twice as well.

We are grateful to the parishioners who conduct Morning and Evening Prayer at 9 am and at 5:30 each day from Monday to Friday. The parishioners who officiate at these small quiet services are: Jacquie deMestral, Uli vomHagen, Bill Naftel, Stan Armstrong, Matthew Vanderkwaak, Sue Zinck, Vaila Mowat and Taunya Dawson. Others who fill in as needed are Richard Kent, Barbara Hodkin and Susan Harris. Fr. Purchase or Fr. Snook have been conducting Wednesday Morning Prayer.

Epiphany

On the Feast of the Epiphany, we welcomed the members of St. Mark's Parish, our daughter church, as they began a year of celebration marking their 150th anniversary year. The Rev'd Vivian Hannon was the guest preacher at this service.

Educational programmes in Lent

A series was offered on Sunday afternoons under the umbrella topic of *Sacred Art and the Spiritual Life* entitled "The Divine Image" designed for our youth, but with others from the congregation and beyond also invited to attend. Mary MacLachlan, Justice Peter Bryson, The Rev'd Dr Gary Thorne and Emma Fitzgerald provided us with a splendid series of show and tell presentations, under the careful organization of Steven Gibson. In addition to the presentations, the young people were also offered a hands-on workshop.

Another series offered on Wednesday evenings in Lent was *Dante and the Renewal of the Soul,* given by the Rev'd Dr. Thomas Curran. Dr. Curran led the group in its travels with Dante through Lent, exploring both the soul's disorders and their healing. These thoughtful and amusing lectures were accompanied by lively questions and discussion.

Also in Lent, Sunday Evensongs featured meditations on the theme: Healing the Seven Deadly Sins. The Rev'd Dr. Paul Friesen introduced the series at Choral Evensong on Lent I and at subsequent Sunday Evensongs throughout Lent, members of our parish family Meghan Jamieson, Thomas McCallum, Fr. Snook, Taunya Dawson and Uli vom Hagen offered a fine series of meditations.

In Holy Week, Colin Nicolle preached on Holy Monday and Holy Tuesday and The Rev'd Dr. Gary Thorne was our Good Friday missioner, taking us to the foot of the Cross with his thoughtful, prayerful and beautifully expressed meditations on the Seven Last Words.

<u>After Easter</u>

In May, Dr. Neil Robertson gave a much anticipated and long discussed series on usury. The series began on May 29th, with the first presentation entitled *The Bible and Borrowing: Old and New Testament Considerations. Classical and Medieval Accounts of Money and Debt,* the second in the series, took place on June 5th. On June 19th, the final presentation brought us into our current situation: *Modern Money: Debt and Credit in Modern Economic Thought.* This was a very interesting series, bringing up many as yet

unanswered questions.

Snook preached the sermon at this ordination and St. George's Music Director and Choir provided the music of the liturgy.

<u>September – November</u>

Following the 10:30 Choral Holy Communion on Sunday, September 25th, Garth MacPhee re-offered his popular *Pizza and Pipes* programme.

On Sunday afternoon, October 16th, Dr. Chris Armstrong, son of parishioners Stan and Barbara, gave an interesting lecture on his recently published book, *Medieval Wisdom for Modern Christians: Finding Authentic Faith in a Forgotten Age with C. S. Lewis.* The lecture served as an introduction to a study group which took place over the subsequent six weeks based on the book, explored the way in which theologians and philosophers of the Middle Ages were able to hold together faith and reason, love and logic and the spiritual and material worlds, in a way which the modern world has lost. The study group concluded just before the beginning of Advent. We are grateful to the Armstrongs for organizing and hosting these sessions.

Educational programme in Advent

Three Sunday afternoons in Advent, the *Sacred Art and the Spiritual Life* series resumed, with a second set of sessions. The topics included "The Development of Christian Imagery: Depictions from the Life of the Early Church," offered by Dr. Marylin McKay, "The Beginnings of Pilgrimage: Dante's Inferno with Interpretations by Gustav Dore," offered by The Rev'd Dr. Thomas Curran and "Later Spiritual Movements: The Gothic Revival and Pre-Raphaelites," offered by Dr. Sandra Alfoldy. Many thanks are due to Steven Gibson for his planning and organization of this programme, as well as to Jordan Gracie for assisting with the set up.

Guest preachers this year included, The Rev'd Vivian Hannon, Fr David Curry, Fr Nicholas Hatt, The Rev'd Dr. Paul Friesen, The Rev'd Debra Burleson, Colin Nicolle, The Rev'd Dr. Gary Thorne, Capt. the Rev'd James McCorriston, Fr Kyle Wagner and parishioners Taunya Dawson and Major Duncan Neish also preached.

We are blessed to have such a loving and faithful Rector in Fr. Snook and we continue to pray for his recovery. Few parishes have a Priest-in-Charge who can slip so easily into a rather complex liturgy and busy pastoral life, but Fr. Purchase is just such a priest and this is another great blessing to our parish. The wardens are also to be commended for their unstinting work for the parish during the past year in support of the Rector, the Priest-in-Charge, and indeed all of us.

Report of the Director of Music

With pleasure I submit a report on the Parish Music for the year 2016.

On Sunday evening, October 23 St George's Choir, joined by extra singers and a wonderful instrumental ensemble, performed Handel's virtuosic setting of Psalm 110, *Dixit Dominus*, as well as Purcell's verse anthem, 'O Sing unto the Lord'. Countertenor Andrew Pickett sang setting of *Salve Regina* by Pergolesi. This exciting musical presentation was a benefit for the Music Room, and what a success it was! \$5K was raised, thanks in large part to a patron who generously paid for the instrumentalists. To the singers who gave of their time and talent to present this glorious music, I offer heartfelt thanks.

In April the Junior Choir was once again awarded Gold in the Nova Scotia Kiwanis Music Festival. The choir sang 'Angels, ever bright and fair' by Handel and 'All Night, All Day' a traditional spiritual. Adjudicator Monette Gould praised the choir for its blended tone and musicality.

On Sunday, June 12 the Junior Choir presented a Children's Concert in the Round Church. A large and appreciative audience turned out to support the choir on this occasion. Once again, we were fortunate to call on the theatre expertise of Karen Bassett, who worked hard to prepare the choreography and staging.

On Sunday, February 28 the Prince Edward Consort under the artistic direction of Andrew Pickett gave a performance of music of the Sistine Chapel. As in the past, funds raised were donated to the Friends of St George's, earmarked for the music programme. Thanks to Andrew and the members of the Consort for so generously contributing time and talent.

Week by week, the St George's Choir prepares settings of the Ordinary, motets and plainsong psalms for the liturgies. The diligence and care with which they fulfill this work is admirable. The musical achievements and accomplishments of each and every singer contribute enormously to the quality of the choir. Through the past year, many new motets and settings were added to the repertoire, including the beautiful eight-voice *Missa Confitebor tibi*, *Domine* by Palestrina, which was sung on Easter Sunday. To chorister Jordan Gracie, we owe a debt of gratitude for his facsimiles of these seldom-performed works. Jordan spends many hours researching musical sources and preparing editions of masses and motets for our choir. We are tremendously grateful for his talent and time.

The Junior Choir continues to rehearse on Tuesdays in the Guild Room, 5.30-6.30pm. It is my privilege and delight to teach this cheerful and dedicated group of singers. Their repertoire includes a range of styles, and they have sung in French, German and Latin. A word of appreciation goes to the parents and guardians who ensure that the children arrive punctually for rehearsal, and for their support and encouragement of the choir.

The music programme owes a debt of gratitude to the Friends of Saint George's Society for their ongoing efforts on our behalf. Without this support, our music programme would not be able to offer the substance and quality of programming we currently enjoy.

In early September, Elisabeth Stones stepped down from her position as Parish Administrator to assume new duties at King's. Happily she continues to sing in the Parish Choir. Her duly selected successor is

another highly valued chorister, Jordan Gracie. We were so fortunate to have such a seamless transition in the office this fall. To both Elisabeth and Jordan, I express my thanks and admiration.

The absence of our beloved Rector this fall has been on all our hearts and minds. Once again, we have been so richly blessed to have Fr Jim Purchase as our Priest-in-charge. His kindness, sober minded good judgment and deep faith have been such a comfort and encouragement in this challenging time. We look forward to Fr Christopher's return, and wish him God speed.

Report of the Sacristan

Report of the Guild of Altar Servers



The servers' guild consists of a number of individuals who assist with various roles in the Sanctuary during the course of the liturgy. This could be anything from getting the bread and wine or collection from the parishioners who come to the rail with those items at the offertory, carrying the cross to lead processions (crucifer), carrying a candle (taperer) to acting as server to bring items back and forth between the Altar and Credence Table for preparation and clean up of Communion. I produce a schedule that typically has three people scheduled for a 10:30 am Sunday service to perform these roles and I include someone to act as the Thurifer when incense is used, especially during High Feast Days. I would like to thank everyone for their continued service throughout the year, especially the following: Rebecca Chipman, Trevor Hannon,

Cathy Larsson, Andrew Thorne, Tovah Vom Hagen and Alan Wilson. Special thanks to Jim Rawding for his continued faithful service at the 8am Holy Communion service on Sunday mornings. Jim performs some of the above-mentioned roles on his own, given the simpler nature of that service. Thanks also to Duncan Neish for helping us out on high feast days especially during Christmas and Epiphany. In 2016 we had a couple of new faces in our team, namely Richard Kent and Clifford Lee. Both have been very valuable to our team. Clifford has not only served but has also been on Alan Wilson's schedule as either MC or Subdeacon . Unfortunately, Clifford has decided not to continue on at this time as he and his family moved to Cape Breton before Christmas to spend some time with other family members before eventually heading to Australia where Clifford, his wife Cindy and their son Lochlan will spend the next several years.

We are always looking for people to get involved as part of our team, whether it be one Sunday a month or a few; on high feast days throughout the week; Crucifer at a Choral Evensong, which happens once a month on Sunday evenings, or all of the above. Some of our members such as Cathy Larsson, Alan Wilson and myself also have duties from time to time on the MC / Subdeacon schedule, which Alan produces as part of his Sacristan duties, so the more people we have the easier it will be to spread the workload to avoid having the same people on week after week. Younger children can help as boat boy or boat girl or even help with some of the other duties on the altar. Rosemary Wilson and Elizabeth Savoury have helped out in this capacity and Olivia Dawson has more recently become involved, as pictured above. Newly confirmed individuals can also help, to get a better understanding of things they have learned during confirmation class, or even adults. Regardless of age or experience, training can be provided if necessary whether it is briefly before or after a service or during a more convenient time. Cathy Larsson has played a valuable role in training servers. She offered to train Tovah and Rebecca when they first started and has worked in conjunction with myself and others to continue training new servers, working along with them to make them more comfortable with being part of our team.

Report of the Sunday School Coordinator

Coordinating the Sunday School has been a joy and a privilege in 2016. January through June we continued with the St. George's Curriculum, Year 1, including a unit on the Apostle's Creed taught by Meghan Jamieson and Vaila Mowat, one on the 10 Commandments taught by Steven Gibson, and another on the Lord's Prayer taught by myself. In between we also had a lesson on Lent and another on Passion Week as well as Easter corresponding with the season, taught by Vaila Mowat. We opted out of a year-end barbecue but plan to have one in 2017 again. During the months of July and August I had hoped to have a less formal Sunday School class meet but found the need to take a break.



Planning for the new school year beginning in September, it was necessary to consider the ages of the group of children who regularly attend. The majority of the preschool and primary Sunday School moved up to be with the older group, and though I considered doing the 2nd year of the St. George's Curriculum, I thought that with such a young group, a focus on the stories and people in the Bible would benefit them more. To this end, we jumped to the 3rd year of the curriculum entitled 'God's People in the Bible' and are basically following the

lesson order provided. During Advent we switched gears to focus on the church season at hand. As I was away for part of October, November, and most of December, Carolyn Gibson took over with teaching and organizing at that time in correspondence with me. St Nicholas celebrations at the beginning of December were low key but successful. And for our nativity play during the 4pm Christmas Eve service Steven Gibson took charge.

We do have a core group of kids who attend regularly, and the babies born in recent months will eventually add to the preschool-age Sunday School which is currently on a sort of pause. Its 'members' include between 1 and 4 kids, ages 1-4 so it has been difficult to offer a consistent set of lessons that holds their attention and is worth the preparation time put in by the teachers at this point. Our solution has been to simply read a Bible story if it appears suitable, though we did do some more involved lessons on Genesis in September and October which worked out well. We decided to purchase a new, and quite beautiful felt board Bible story set which will be used by both the younger group and the older group in months and years to come, once it is fully cut out and organized, a job which Kieva Diamond has graciously been heading up.

Thank you to all the teachers, helpers, parents, students and those who pray for our Sunday School. Our prayer time, lessons, activities and fellowship, are meant to not provide 'babysitting' but to add to the life of St. George's as we care for and nurture the minds and souls of St. G's youngest members. My gratitude goes out especially to:

Fr Christopher for his prayers, guidance and leadership, and Fr Purchase in the fall and into December; Elisabeth Stones for the first part of the year and now Jordan Gracie, for their help on the administration end of things and all they do to support this ministry to the children; Susan Harris for continued encouragement as the Chair of the Spiritual Development Committee; the Wardens; Carolyn Gibson for stepping in to organize the St. Nicholas celebration and for teaching in my place while I was away; Steven Gibson for heading up the December 24 Nativity Play; Kieva Diamond for help in cleaning out and taking the first steps in reorganizing the space of the toddler room, and for getting the felt board ready; Meghan Jamieson, Benjamin Lee, Vaila Mowat, Heather Neish, and Duncan Neish for teaching; and all teachers and parents and the congregation for their support through words of encouragement, friendship, and prayers for the St. George's Sunday School and all who are involved with it.

Report on the Parish Archives

During 2016 the Archives Room in Trinity House underwent more improvements. Most notable was the donation of two filing cabinets, which will help secure valuable records.

Several projects were organised for our summer student. Most notably digital photographs were made of brass plaques that had been removed after the fire of 1994. Projects are now being considered for summer 2017.

In May, I met with Parish Council to update members and answer any questions regarding the new room or future projects.

A much needed large transfer of records was made from the Parish Office. The records include Sunday School Curriculum, Parish Council minutes and other typical parish office circulars, correspondence, reports and so forth. Framed photographs from the Parish Office were also received. Some items suitable for the archives were also retrieved from the old "music room" in the Round Church.



A beautiful painting was donated to the Archives by John and Margaret Tarrel of Gagetown, New Brunswick. It depicts a night sky including a comet (Halley's Comet?), as seen through the roof of the Round Church following the 1994 fire. They bought the painting from an artist during a restoration fund raising event in 1994. The name of the artist remains unknown. If anyone can shed any light on this unique acquisition, please get in touch.

Some of the research inquiries received this year included requests for a painting or architectural plan of Trinity House,

for architectural plans for the windows in the church, and for information from the vestry minutes (which are currently stored at the Nova Scotia Archives).

Our Archives could certainly use a map filing cabinet for architectural plans, which are best stored flat rather than rolled. If anyone locates one for a reasonable price please let me know. Respectfully submitted,

Report on the Parish Library

As some of you may have noticed, since October 2016 and thanks to the 'vision' of Jordan, Office Administrator, the Parish Library in the Guild Room has taken a new physical shape .The glass-doored barrister's bookcase has been turned around, and the large old book cabinet with wooden doors has been moved so that together ,with the re-positioning of the librarian's desk, a small nook has been created which better represents our Parish Library .As well ,two 6 ft. open-shelf units were brought down from a storage space under the dome of the church and placed in this new area . This was labour-intensive not without 'blood, sweat, toil, and [almost]tears!' There was discussion about the possibility of having doors made for these open shelf units but their framework will not allow this .So, at the moment, I am uncertain how I will make use of this new book storage space.

My budget for the past year was set at \$100, and I have spent approximately \$36 on three new books for the library. I have these, and many other donated books, yet to catalogued and made available to the congregation in the coming year.

My focus continues to be the used book sales following the Sunday morning services. From January to May 2016, approximately \$120 was made and channelled into general funds for church expenses. Starting in September 2016 I joined ranks with Michal King for the continued sale of 'used books and more'. Please see Michal's fundraising report for details.

Many thanks to all our generous parishioners for donations to and purchases from our Sunday sales. We will continue these sales as long as there is interest, and donations of items to sell.

In this new year I hope to provide a collection of St George's notecards and postcards for sale / donation in the church for the visits of tourists this summer.

Report of the Property Committee

Last year at our AGM, I volunteered to chair and try to reinvigorate the Property Committee at the cost of stepping down as one of your Wardens and over the past year, I can report to you that the scope of work undertaken on or about the Round Church has been staggering.

The past twelve months have shown a great deal of change and progress in the care and preservation of all our holdings, and this has been most evident in the work that has gone into the grounds themselves, but also there has been much work done to the fabric of the church, hall and Trinity House as well. The most obvious change is perhaps the paving of the parking lot which has created far more useable space, facilitates improvements in winter clearing operations but above all, in life and safety considerations for all who use our lands. The church has seen significant exterior work as well, including but not limited to column repair on the front porch, new frieze boards and facias, new roof shingles, in particular over the porch and southern side of the church, new paint and wall shingle repairs. The interior of the Church has seen some attention as well, in the form of new LED lights and updated dimmer switches to control the new technology. I would like to especially thank Roy Currie for overseeing this project. It will surely make a significant impact on our hydro expenses over the

to the Deck the Hall campaign. Even Trinity House has gotten some much needed attention, primarily in the form of a new bathroom for the use of the house residents who also act as Sextons for our properties. The past year saw the need to reexamine our cleaning contracts for the hall, which upon review we found their performance to be seriously lacking and underreported and consequently, they were dismissed. We were very fortunate to find folks within our parish family who were willing to assume the duties of custodians and I am very pleased to report that their work has been very good indeed – thank you! Projects for the coming year are starting to take shape. As some of you may have noticed, our hardwood floors in the Sanctuary and especially the Chancel are in dire need of attention and quotes have been invited to refinish them. I have spoken with competent and reputable people in the business of such and they assure me that the work is not as serious as it might look. In the summer when the LDC reopens, there will be a period when the Round Church will have no Chancel or Sanctuary access to allow for the refinish work to happen. This may create a one or two week inconvenience in our use of the church but looking at the bigger picture, it is necessary to preserve the fabric of our beloved building. As we get closer to the time, more detail will come.

The next major initiative is currently underway. An application for a grant from Parks Canada has been submitted with the aim to repair and restore the Chancel windows. This is still in the application stage and hopefully, with all our ducks in a row, and a favourable response, this important work can commence in a timely manner. From down below, the windows look fine but upon close inspection, the years of weathering have deteriorated them to a point where there is a real concern for their condition that demands a full response. There will be more on this in the months to come.

Lastly, I want to thank and acknowledge the members of the Property Committee who have courageously stepped forward to help out with this important office: Roy Currie, Bill Naftel, Uli vom Hagen, Alan Snook, Mike Himmelman, Matthew Vanderkwaak and Justin Wollf. These gentlemen are my eyes and ears and occasionally hands, and if there is something that is of concern that you as a parishioner wish to bring forward, you can ask one of them or myself and we will address it.

Report of the Implementation of the "5S" organizational system in the Parish Hall

In September of 2016, the Rector and Wardens of the Parish of Saint George incorporated the duties of a "5S" Coordinator into the job description of the Parish Administrator, and ordered the Parish Administrator to bring the Parish Hall into a state of compliance with the 5S system of workplace organization.

"5S," also called "visual control," is a system developed by the Toyota Corporation in the 1970's and 1980's in order to cut down on training time while rotating workers through different factories. The goal of the system is to create an environment where an individual who is *not* familiar with the space can determine if any item is missing or out-of-place in 15 seconds or less.

In order to accomplish the implementation of this system on three hours per week, I divided the hall into sections, and evaluated each section based on two criteria: 1) the ease with which a single person might, unaided, bring that space into 5S compliance; and 2) the potential rental revenue of that space, once cleaned and organized.

As of 31 December, 2016, the Guild Room has been reorganized: the Parish Library has been moved into its own designated space, unnecessary shelving and furniture has been removed, and surplus furniture from elsewhere on the Parish property has been moved in. The result is the creation of a 450 sq. ft. meeting room that is capable of seating up to 16 in boardroom configuration, or up to 26 in theatre configuration at no real expense to the Parish.

At the urging of the Wardens, the Sunday School Room was designated the "next in line" to be brought into 5S compliance after the Guild Room, and a plan for the accomplishing of the same was drafted. Before 31 December 2016, both Saint George's YouthNet and the Sunday School were given written instructions and a deadline of July 15 2017 to bring the Sunday School Room into a state of 5S compliance; if the Sunday School Room is *not* brought into a state of 5S compliance by 23h59 on 15 July, 2017, I will, as 5S coordinator, bring that room into a state of 5S compliance on behalf of all of the users of that space.

The issue of the state of organization in the Parish Hall is, on one hand, frustrating, and, on the other, something of a delicate subject. The legal reality is that the Parish Hall has three commercial tenants who use the Hall without any sort of contract, memorandum of understanding, or formal agreement for the use of the space. These three tenants are: Saint George's YouthNet, Halifax Humanities, and the 2^{nd} Halifax Scouts. Commercial tenancies are completely unregulated in Nova Scotia - there exist no standards, guidelines, regulations, or minimum requirements - so there is nothing stopping a landlord (like the Parish), from ordering its staff (like the Parish Administrator) to enter and reorganize a space that is occupied by a tenant, used by a tenant, and used to store the assets and possessions of that tenant (like the Sunday School Room, the Scouts' Room, the C@P room, PlaySpace, or the storage closets opposite the western furnace room), but it is still something of a rude thing to do without advance notice. I am ever mindful of the fact that an organizational system which is not, first and foremost, useful to those that use a space and its contents will not be maintained. I am doing my best, therefore, to ensure that this organizational system is, above all things, useful to those that use the Parish Hall.

Report on the Soup Kitchen

St. George's Soup Kitchen operates on Saturdays throughout the year. Team Leaders arrive at 2:00pm to begin setting up, volunteers arrive at 3:00pm, clients are served between 4:00pm and 5:00pm, and clean-up (ideally) is finished by 6:00pm.

This year, volunteers rotated every six weeks: Team 1 was led by Maxine Miles; Team 2 was led by Mary Hills and Michelle Gabriel; Team 3 was led by Mike and Wendy Himmelman and Michelle Gabriel; Team 4 was led by Evelyn Mann and Michelle Gabriel; Team 5 was led by Jacquie de Mestral and Leona Sweeney, with food and volunteers consistently coming every six weeks from Bedford Baptist Church, organized by Bonnie Matthews; and Team 6 was led by Michal King and Michelle Gabriel.

The Soup Kitchen is heavily reliant upon its partner organizations to provide both additional volunteers and any food which is not bread or dessert, and is entirely beholden unto Feed Nova Scotia and 24 Carrots Bakery for weekly deliveries of bread, desserts, and fresh foods.

Figure 1: Number of People Served in 2015¹:






Figure 2. Number of People Served in 2016²:

Deaf Ministry Report

St. George's has been blessed with a long history of ministry to the Deaf and the faithful participation of the current members of our Deaf community continued through 2016. Deaf parishioners attend both Sunday and Wednesday worship and are active participants in fellowship, meetings and other events. The Deaf Club also continues to meet in our parish hall about once a month. As I said in last year's report, the friendships fostered within the parish have been a real blessing for St. George's.

As always, we are grateful to our Interpreters, Jessica Bezanson, Ashley Campbell, and Karen Anne Smith for their steadfast commitment to this ministry. In addition to the organizing of the schedules for Sundays and Wednesdays, they stay in contact with our Deaf parishioners and are often able to serve as helpful liaisons with the parish through the week.

At the beginning of 2016, Carol Morrison, one of our very faithful Deaf/Blind parishioners saw a decline in her health and was no longer able to attend church as she had done regularly for so many years. Our clergy continued to visit her in Northwood, but we missed her in church on Sunday mornings. It was a real blow for our parish when she died in the fall of 2016. A Requiem Eucharist was celebrated for her at St. George's on Wednesday, November 23rd, with a good representation of our parishioners present, as well as many from the wider Deaf community in Halifax.

Throughout 2016, Allan Snook has been driving Agnes Comerford to church on Sunday mornings and we are very grateful to him for this kindness.

Report of the Saint George's Refugee Sponsorship Committee

Since this time last year, the Saint George's Refugee Sponsorship Committee has been active in both obvious and less visible ways. We raised \$55,000 through a remarkable outpouring of support for refugees. The community that we became in our activism was a great pleasure and a way for us to get to know many people close to the Saint George's community. We are grateful for our collaboration particularly with King's students, Saint Patrick's Roman Catholic Church, Nova Scotia Legal Aid Lawyers, and community activists. We still await the arrival of the Almasalma family from Syria (and they remain in Jordan); and we continue to email and Skype with them. They know that we consider them part of our community. I, personally, continue a lobby effort on their behalf with frequent emails to our Member of Parliament. Members of the committee are hard at work helping an Iraqi family to settle in Halifax: we took on this sponsorship from a small group in rural Nova Scotia because the family could not find the community and language-training that is crucial to their settlement here. We have applied to sponsor a family of six from the South Sudan. They are relatives of one of our parishioners, and while we hope that they will arrive in the near future, we know that this may be a long-term commitment. Just now, students from the University of King's College are gathering to think about how they/we can continue to support refugees here in Halifax and abroad.

Report of the Director of Saint George's YouthNet

Despite the vast mix of tragedies and successes in the North End community this past year, YouthNet continues to be a place of support and safety for children and youth living in the North End neighbourhood. The continuing success of the program is due to the shared dedication of volunteers, community members, parishioners and YouthNet staff who are committed to providing vulnerable youth programs that are engaging and meaningful, supporting their physical and mental health, their sense of belonging and feeling of self-worth. Each year YouthNet hopes to engage youth in new opportunities and encourage them to try what may be outside of their comfort zone, in order to help them build self-confidence and help them envision many opportunities for their futures, despite the constant barriers they frequently face. The joys and successes of this past year and the new friends we have made are reflected in this report, in an attempt to share some of these valuable memories with you.



This past year, YouthNet has finally seen some stability in its staff and volunteers which has helped programs to grow and flourish. Rozzi Curran and Sarah Krahn continue as YouthNet's full-time employees in the roles of executive director and program coordinator. Diego Fay fulfilled the role of lunch coordinator for another year, preparing food for students at Joseph Howe Elementary School. Shaquille Armaly joined the teen program in September, working as a teen coordinator alongside Michael Earle. YouthNet's board continues its hard work and two new board members joined the team this year, Fr. Jim McCorriston and Davinia Wright, our treasurer. The YouthNet board supports

YouthNet staff and continuously upholds YouthNet's work, the youth and their families in prayer.

Lunch program served up to 24 students a hearty lunch daily at Joseph Howe Elementary School this past year. We are eternally grateful to the generous support of the Department of Community Services, Feed Nova Scotia, McInnes Cooper and our incredible lunch providers for making this program possible. Without this support, it would be very difficult to continue offering this program. The students look forward to the lunch they receive from YouthNet every day and this program helps them make it through their long school day. Joseph Howe's student population has grown rapidly this past year with the addition of 50 newcomers from Syria to the school in February. It has been incredible to develop new connections with these students as they become settled in Canada. The YouthNet staff develop friendships with many students at the school, helping us to find children to introduce to our programs in the future. We feel very fortunate to have such a strong connection to the school's students and teachers. Our after-school program for 21 children in grades 2 to 6 continues to be the staple of our programs, as we explore a wide range of interesting, stimulating and meaningful activities to help youth discover new talents, build friendships, develop leadership skills and enjoy themselves. We welcomed several new children to the program this past year; all of whom we became friends with at Joe Howe School and encouraged to join us. Our volunteer numbers have also grown, and in the fall we had at least 2 or 3 volunteers every day after school. We could not do what we do without their support, and are eternally grateful for their help and love for the YouthNet participants. These volunteers are mostly university students who attend Dalhousie, King's College, Saint Mary's and Mount Saint Vincent.

After- school program activities in the first half of the year included swimming lessons at Centennial Pool, tutoring at Joseph Howe, African drumming and dance, science workshops with Let's Talk Science and tutorials on building a robot. In the fall we had weekly art workshops with Kate Wright, visits to the library on Gottingen Street for music, art and science, weekly cooking workshops and frequent visits to the Oval for rollerblading. This past year we tried many new things, and were pleased to see how well the youth responded to activities outside of their comfort zone. This program is made possible thanks to St. George's, United Way, McInnes Cooper and Halifax Youth Foundation.

Teen program continued this past year on Tuesday and Thursday evenings and as of the fall has close to 20 participants. This program is heavily supported by the Rotary Club of Halifax Harbourside and the Anglican Foundation of Canada. In this program, teen program coordinators strive to teach the teens new skills, have engaging conversations with them about themselves and the world around them and share a meal together at the end of the evening that the teens take turns cooking and cleaning. Highlights of teen program in the winter and spring included guest speakers, swimming lessons, skating at the Oval, hula hoop and fitness classes, woodworking workshops and various outings including basketball games and the Escape Room. In the fall the teens frequently played trivia and jeopardy, made various art projects, organized a Halloween party for the after-school program, went on outings to NSCAD and attended WE Day.

YouthNet's summer was filled with excitement and energy, which was shaped by 4 day camps and 3 camping trips throughout July and August. We had the incredible opportunity to collaborate with Hope

Blooms for two of the summer camps. The first camp provided the children the opportunity to learn about gardening, medicinal herbs and plants and cooking with local ingredients. The second camp was about entrepreneurship, providing the youth an opportunity to create a product and sell it. Other day camps included Busy Bees, for 5 to 8 year olds, which featured swimming, art, sports and various exciting outings around Halifax. Our final camp of the summer was called Creative Cats and featured a wide range of arts-based activities including singing, dance, painting and writing. The camp was hard work for the participants but it paid off; the week was a huge success and the youth were very proud of their accomplishments, having learned choreography to a hip hop, salsa and ballroom dance. This summer's junior camping trip for 7 to 10 year olds was at Rissers Beach. The weather was incredible and we spent our time swimming in the ocean, going on walks and fishing. The teens spent a week canoeing at Kejimkujik and our annual hiking trip to Cape Chignecto was cut short when all provincial parks were closed due to the dry weather. Despite this unfortunate situation we had an incredible summer and great weather on all of the camping trips which allowed us to swim, canoe and hike in the sunshine.


