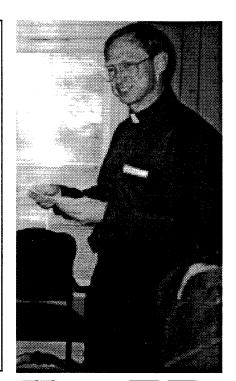


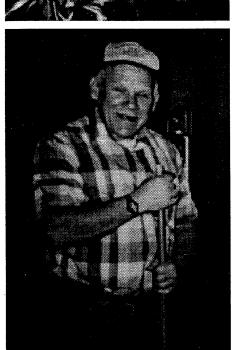

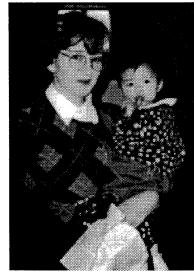

Minutes

Annual General Meeting, Sunday, February 23, 1997

Sixty eight parishioners were present. The Meeting began with the singing of Hymn 802.

The agenda was approved as printed and distributed.

MOVED: Charles Westropp, SECONDED: Mary Martin. Be it resolved that the Minutes of the Annual Meeting of February 18th, 1996 be aproved as distributed. CARRIED.

COMMUNICATIONS: One letter was received by the meeting dealing with the Synod and the move of each parish into the 21st century.

FINANCIAL STATEMENTS: were presented to the meeting. Neil Robertson enquired about the presence of investments in the face of Committed Fund Liabilities and a debt to the allotment.

Michael Johnston explained that this was simply a cash flow situation and there was not really a cash surplus.

Gertie Moulton asked what the exact amount of the deficit

was. KW to I Sooo with reflected Mary Martin was advised by Michael Johnston that the allotment was not paid.

Fr. Thorne explained that the Parish Council in an attempt to be pro-active with regard to the allotment instructed the Executive Committee to request that a moratorium be placed on the 1996 allotment and one half of the 1997 allotments. While favourably received, the Bishop had advised that this could not be done in advance but could only be addressed once the Parish was in arrears. The Parish has received an invitation to sit down and address the allotment. Gertie Moulton requested that we be presented with financial statements that are able to be understood.

MOVED Michael Johnston, SECONDED Karen Wheeler Be it resolved that the financial statement for December for December 31, 1996 be adopted. CARRIED

RECTOR'S REPORT: Fr. Thorne apologised for his part in the Modest Proposal Project stating that he had misinterpreted the will of the Parish. He advised the meeting that the proposal to open the hall to provide tea and coffee to the street people of the North End had grown from the expressed interest of several individuals to extend the inner city ministry of the Church.

When a meeting was held to discuss this new approach it became clear that other factors had not been properly considered. As a result it was clear that the hall was not a proper venue for this outreach. Because the news media had taken a statement of Fr. Thorne's out of context he had refused further comment. Fr.Thorne requested that others not speak to the media on behalf of the Parish...this request was not adhered to. The meeting was divided over the issue; some feeling that the matter of media contact be dealt with immediately by the Parish, others feeling they

should be able to speak freely. Sandra Thorne suggested that if someone speaks, they make it clear that they are speaking on their own behalf.

MOVED Jane Mason-Brown SECONDED Karen Wheeler Be it resolved that the Parish executive meet today and consult with whom they deem necessary to immediately resolve this issue. CARRIED.

Fr. Thorne apologised to Frank and Roxanne for the fact that marriages must be registered in the Parish in which they occur. This is the reason there are no weddings or burials included in this report.

Fr. Thorne thanked Jan Connors for her overwhelming contribution.

WARDENS' REPORT: Jan Connors presented the report as written and thanked her family and employer for their support during her wardenship.

MOVED Rob Martin SECONDED Michael Johnston Be it resolved that all committee reports as printed in the annual report be adopted. CARRIED

MOVED Karen Wheeler SECONDED Jan Connors Be it resolved that the organization reports as printed in the annual report be adopted. CARRIED

Alan Edwards complimented David Harris for his work in the Parish.

Bruce Archibald advised the meeting that the Restoration Financial Statements were not available and inquired as to whether those present felt there should be a special Parish meeting to consider the statements when they become available.

Neil Robinson asked about the viability of the fundraising

MOVED Neil Robinson SECONDED Rob Martin Be it resolved that the Parish Council receive and consider the un-audited financial statements of the Restoration Committee and the statements part of the 1997 annual report. CARRIED.

Fr. Thorne noted that the Gabriel Guild had given \$7,000 to the Parish and that the Scouts had raised a considerable sum of money through chocolate bar sales.

MOVED Michael Johnston SECONDED Sandra Thorne Be it resolved that the 1997 budget be accepted. CARRIED.

Anne West pointed out that the reason the budget was balanced was because the allotment was not included. Several members of the Parish felt that the matter of the allotment should be addressed.

5. PRIOR PERIOD ADJUSTMENT - ALLOTMENT ARREARS

The effect of the adjustment to correct this ommission is to increase accounts payable and accrued liabilities and to increase the deficit each by \$5,281.

Rector's Report

In 1997, worship of the Triune God was the beginning and end of our parish life.

Our worship is centred on the Holy Communion in which we receive Jesus Christ in His Word and Sacrament. In our parish we are increasingly giving prayerful attention to the way we worship, so that we might best position our souls and bodies to receive spiritual blessings. We are developing a biblically rich and predictable liturgical form which embraces both intentional quietness and beautiful music in order to draw us into an experience of God's Love for us in Jesus Christ. When our worship is graced by the Holy Spirit we find ourselves keenly aware that we are in the very saving presence of the Person of Jesus Christ. His love converts us to Himself again and again, more and more profoundly. We have been so fortunate to have had two music directors in 1997 who understand the purpose of our liturgy and worship. Throughout her music Sarah MacDonald taught many of us how to pray and Garth MacPhee has continued by writing many prayers on our hearts.

Everything we do, say and sing during worship has the sole purpose of focusing our hearts ever more intensely on the Love of Almighty God which has come to us fully and freely in Jesus Christ by the power of the Holy Spirit.

An important part of our worship at Saint George's is the recognition of the 'calendar of the soul' or the liturgical year which allows the Holy Spirit to shape and form our personalities by ordering our lives within the life of our Lord and Savious Jesus Christ.

Even the activity of restoring the Round Church has been a witness to our worship and devotion. Our moving for worship

between the Hall and the Round Church has been in accord with our spiritual life. During Advent 1996, we prepared ourselves spiritually to re-enter the Round Church on Christmas Eve to celebrate the incarnation of the Son of God. We remained worshipping in the round until the end of the Christmas/ Epiphany season in which Christ is manifested to the world as Lord and Saviour. As we processed back to the hall for a holy Lent we imagined ourselves within the story of the forty days of Christ's temptation in the wilderness. We thus were able to attend seriously to our spiritual preparations to reenter the Round Church for Holv Week and Easter. Back to the Hall after Easter, only to return to the Round church to celebrate the glorious Ascension of our Lord into Heaven. Each step a step with Jesus.

Our daily offices of Morning Prayer and Evening Prayer are faithfully offered to God on behalf of the whole parish by devoted parishioners. The presence of two members of the Religious Order of Celi De in our parish is a great addition to the praying of our daily offices.

Prayer begins and ends every one of our many committee meetings at Saint George's. We are truly blessed in our parish family to have so many committed parishioners in significant leadership positions who understand the Christian spiritual life. Our Restoration Chair, Bruce Archibald, is always quick to remind us that everything we do must be only for love of God and love of neighbour.

Senior Warden's Report

The terminus of this adventure is in sight. My wardenship is nearing its expiry."Best before March 1998".

You good people at Saint George's are to be commendedfor your acceptance and support of this Anglo-Lutheran. I did not really want this position, it seemed too high an honour and too great a responsibility—I had too little available time and resources. I was not the right person for the job. But what I did I know? When the Spirit calls....

And so for two years I've served as a silent partner, alongside Jan Connors and then Mary MacLachlan. Their eye for details and thoroughness matches any engineer I've ever known, and their energy level exceeds that of most aerobics instructors. I am very grateful for the honour of working with them.... if it could be called work, for all I did was to listen to people and toss out a few thoughts now and then...and pray. This position requires a lot of praying.

My report could be reduced to one notion: amazement. Former wardens will understand this already, and now the rest of you might as well.

First I am amazed at the people of this parish. There is such a rich diversity among us, it is almost unsustainable—and would be if we weren't regularly reunited in Christ at His Table. Thus, thanks to our unity in Christ, our diversity leads to divers forms of ministry within the body of Christ, in our parish, our community, our world. And here it is that I stand back in awe; I am humbled by the sight of so many of you deeply involved in the ministries of this parish... giving your time, talents and possessions, giving your SELF, cheerfully, sacrificially, some-times thanklessly, often invisibly.

Also amazing is the fact that we haven't self-destructed. Though our love and commitment may be strong, they are not pure. In fact they are downright dysfunctional at times.

If we could only fulfill the Law of God: to love God with our whole heart and our neighbour as ourselves. Then worship attendance would double...and so would stewardship ...programmes and committees would run at peak efficiency...contentious and divisive issue would disolve ...and all problems would be seen to be false problems. If we could love one another and God as we should, then our commitment to Christ and His people wouldn't be shaped or misshapen by our sin and darkness ...and our relations with others would be free of hidden agendas, neuroses, fears, suspicions, envy, jealousy and whatever else it is that leads us into conflict and absurdity.

But that is the one thing that we cannot do...for if we could so love, we would not need a saviour.

What is most amazing, I keep finding, is the grace of our God, who is committed to US with a love that will never let us go. We cannot love one another as we ought, nor can we serve His church as we should. Jesus once told his disciples that we can do nothing without Him...and most of our problems arise when we think we can. We are not the little engine that could, when it comes to works of

Junior Warden's Report

1997 is significant, marking the first full year of worship in our church since 1993. This year we lived the Christian calendar of liturgical seasons in the circular embrace of the Round Church. As the ancient Jews knew in Babylon in the sixth century before Christ, this is the greatest grace of all: to worship in the holy place called home. Our exile in the parish Hall was trying but it is both a reward and a triumph to return, observing Christmas, Epiphany, Lent, Easter, Trinity and Advent at home again after much sacrifice and effort. Let us recall that we were enjoined by the rector to enter the church in humility.

Our first year home again exposed new capacities for resilience. We maintained and expanded programmes even as the leadership was called elsewhere. Sarah MacDonald, who taught us much about approaching divine mystery in music, has left this year to study in Cambridge. Our new music director, Garth McPhee, confirms again our good fortune in leadership of the Music Programme. Garth has shown choristers and congregation alike new possibilities for worship in song. Regrettably, other active parishioners also had to leave for other responsibilities: Alan Edwardson, Cynthia Watts, the McCorristons, Alice Johnston. It is clear, however, that their contributions to Youth Work, Soup Kitchen, Nursery, Sunday School and the Christian Education Curriculum leave these projects enhanced and functioning well. Thankfully, every leavetaking has been answered with enthusiastic, organized volunteer energy from the congregation.

In witness to the rector's eight years of faithful guidance we continued steadily in worship and outreach during his four week study-leave at Durham University this fall. We may be humbled and also very proud that Father Thorne is called to serve God in research and study with a renowned scholar at one of the finest theological departments in the world. That he does this while continuing to respond fully to the north end community of Halifax is a testament of God's grace at work and a reminder of the diversity of gifts and strengths given to us all.

Expanded programmes and the restoration of the church have taxed this small parish; many are tired — drained, even — from extra responsibilities. There is resilience, nevertheless, in our response to the Parish Challenge to meet a goal of \$10,000. At Jim and John's Fabulous Pizza Party, Bruce and Martha's Kitchen Music Night, Gai Thomas's Vegetarian Feast, and Michal King and Heather Hannon's Death by Dessert and Silent Auction we saw that we are a diverse and gifted lot and that we still know how to have fun.

As junior warden I learned that this is a ministry of listening: to parishioners in the Hall, to Sunday Schoolers, to committee decisions, to music, to community response to our presence, to those attending fabulous Gabriel Guild dinners, and most of all in listening to the Word of God in the cyclical rhythm of

love. When we act as though OUR wills and efforts were instrumental in accomplishing the works of Christ, then we're heading for the abyss. The amazing thing is that we we have not slid into it yet. God won't let us! He accomplishes His purpose through us, despite the well-meaning obstacles we put in His way, and despite the certainty with which we head straight for the rocks.

It's when God takes hold of our wills and makes them His own, and when our love is nothing other than His love in us, that this entity known as the Church heads in the right direction. We are not a civic organization, it's not our wills, our decisions, our efforts which ultimately matter. The most we can do, if we do anything, is to get out of the way, and allow God the opportunity to do His work through us....which He commences over and over again, amazingly enough, every time we meet his Son at the Table.

Four motions were put forward:

Group Sessions.

1. Envisioning the Church of the Future.

A number of stories were shared with the people in the groups about how they reacted when something new was introduced or something markedly changed their life. From this list we drew upon the most important lessons learned and then listed those in order of importance. From this we created a recipe for a "new church". It was agreed by all in our group that Tolerance, Understanding and Acceptance were the best ingredients for a Church of the Future.

2. Building up the Body of Christ. Again, a number of stories were shared with the group that focussed on one common theme: a time when someone did something for me and what this taught me about being a Christian. From these, we tried to decide what resources would be

needed, what obstacles would have to be overcome and how churches could work together to build up the Body of Christ. A presentation was given by each group to try and convey what they thought would be a good example of how to "Build up the Body of Christ."

3. I am among you as a Servant.

Here the groups got together to study a section from the Bible. For reference the three passages were Matthew 5:39-42, Luke 11:5-8 and James 2:12-26. Reading these will show you a commonality about how a Christian should perform with respect to his bretheren. It is from these lessons that good Christians are born and people are shown how they too can be servants of Christ.

Conclusions and Impressions.

Synod was an interesting experience that should be shared and I encourage all to attend it some day. Only then can you grasp what Synod is about and the fellowship that is enjoyed there.

We are a small, diverse and ambitious congregation. Because of this there are many ongoing as well as special projects which exist and continue to survive through the extraordinary efforts of many individuals. Special thanks are due to Father Eldie Richard, the Reverend Jim Snyder and Father Strople. By taking on responsibilities for services, preaching and other work from time to time, these three have made it possible to make unusual demands of our rector. Our sacristan Craig Botterill, Vaila Mowat and the Altar Guild, and Scott Connors as head of the servers have all ensured smooth transitions into and out of the church. Due to the forethought of Father Thorne, these moves have coincided appropriately with events in the Church year.

1997 has been a year of transition in leadership. Sarah MacDonald returned to Cambridge and Garth MacPhee is our new music director. Alan Edwardson, our youth worker, left the parish to return to his studies. After many years of service our altar guild retired this year and a new guild is gradually being formed. Alice Johnston, our Sunday school teacher, left the parish at the end of the year.

We now have two Franciscan brothers in our parish. David Winter

has joined Brother Craig in this vocation. The Bishop has given permission to Craig Savoury to administer the chalice. Two former parishioners were ordained to the priesthood; David Harris in Saskatchewan and George Westhaver in England. Long time parish friend Jeff Reed was ordained in St. Helena. Jim McCorriston was ordained deacon in Halifax.

Teaching

Alice Johnston very capably taught the Sunday school class of up to 24 children and continued work on the curriculum project. Vaila Mowat has organized a parish library. The Monday evening study group continued, reading Christian authors spanning 1,500 years (Saint Augustine to Simone Weil). It is currently studying The Rule of the Society of Saint John the Evangelist. In response to questions from parishioners regarding liturgy and doctrine, our rector has begun a series of short essays on these subjects for distribution.

Memorials

The Conrad family has generously donated funds which will provide interest each year for the Pickford Memorial Choral Scholarship. This will be awarded annually to a young chorister who demonstrates promising musical talent and leadership skills, as well as a

developing appreciation for the liturgy and worship of the church.

Youth Worker

Alan Edwardson worked on the development of the Saint George's Christian Education Curriculum and continued his ministry to the youth of our parish with children's talks on Sunday, co-ordinating the Sunday school, and leading the senior youth group with worship services and meetings. His outreach to the community continued under the umbrella of "Camp Saint George" and included Christian education in the schools, Beavers, Cubs, Scouts, Rainbow Girls, noon-hour cub and scout programmes, vacation Bible school and summer camps for neighbourhood youth. Brian and Jean Butcher assisted him with the last and very challenging project.

Visits and Missions

The Reverend Stephen Vail led a Lenten quiet day and Bishop Mutter gave our Good Friday address.

Final note

Sandra Thorne and John Swaine have been designing and overseeing the making of vestments. A purple set arrived for Advent and a white set to match our white frontal is in progress.

Report of the Music Director

My appointment as music director carries a very personal significance, more recently through my friendship with Sarah Macdonald, but particularly through Michal King, who is not only a long time friend, but was also my piano teacher when I was growing up. Saint George's provides me with unique opportunity to develop my skills in a spiritually nurturing environment, and for this I am grateful.

Since my arrival many of you

have expressed your appreciation for the music and in particular for the choir. It has been very satisfying to work with a choir which understands both the liturgical and musical aspects of their singing.

At present there are nearly thirty choristers: adults, university students, teenagers and children. Auditions are held on a regular basis for both new and returning choristers. While the levels of musicianship vary, the goal of

musical excellence remains constant. Many of the choristers take private lessons to enhance their contribution.

In September, Barb Kail became the first recipient of the Pickford Choral Scholarship. The annual award goes to a deserving young chorister who demonstrates not only musical talent but also leadership skills. It is my hope that this scholarship might eventually be awarded to a junior and senior chorister.

Music Director continued

Since July, a small liturgical choir has faithfully kept the office of sung Compline each Sunday evening. For many of us this has been a source of great strength. Compline has on two memorable occasions provided us with the opportunity to remember the faithful departed, once following the death of Harry Boswell and after that of Faye Armsworthy.

Besides maintaining a busy schedule of Sunday worship and

feast days, Saint George's choir, under Sarah, gave a concert of church music in the spring. The choir also sang at Harry Boswell's memorial service in November, as well as at the Royal Canadian College of Organists carol service at All Saints' Cathedral. The Advent Procession service was held in the Round Church for the first time since the fire.

I wish to thank Andrew Pickett for his excellent work as choir librarian, as well as our rector, Gary Thorne, whose encouragement and spiritual leadership seem to elevate our music to worship.

Pastoral Care Committee

Some people bought turkeys or potatoes. Other people cooked turkeys and peeled potatoes. Other people served them. One person brought a Christmas tree. Several donated gifts. Others did

Property Committee

General

For many years, the Parish has been unable to do much preventative maintenance on its properties. Only essential work has been done, that which was either for safety reasons or to repair damages. There is a price to pay for low on-going maintenance. This will neccessitate a serious look at the future use of Parish buildings. We must consider the economic and social benefits of being landlords. We should examine the multiple uses of the Hall and look for ways to maximise rental income both for the Hall and the Church, and ways of reducing expenses. Volunteer efforts figure prominently in the equation to eliminate some costs.

Rectory

In spite of a very restrictive budget, and thanks to many volunteers, we were able to accomplish some essential work on the Rectory. The exterior was painted by University Painters. The second story bathroom benefited from a new tub enclosure, ceiling fan and paint job. The first floor bathroom was painted and a ceiling fan installed. We repaired the back porch and installed plugs and finishing gyproc. We are thankful for Daisy Maguire's tenancy in the Rectory. It has been her home since 1985 and she performs her own kind of ministry by renting to low income individuals and students.

Hall

In June, sailors from American warships visiting Halifax began the

much needed painting of the exterior of the Hall. University Painters finished the job in July. Staging and Ladders were donated by Steeplejack Services, Aluma Systems and Butler Scaffolding. Many thanks for their generosity. Repairs were made to door thresholds, window sills and shingles. The entrance to the Restoration Office got a new doorsep and deck and a new door was installed at the Maitland Street entrance. The interior saw a lot of shuffling of groups. Karen Wheeler got a new office in the old Waldorf room; the choir is now ensconced in the old Sunday school room and the soup kitchen storage moved to the scout room. The scouts landed back in their original room and the Sunday school has a spacious home in the old Waldorf room.

Major work needs to be done in 1998. The roof needs repair, possibly replacement. The chimney on Maitland street needs lining to avoid the on-going expense of repointing every other year.

Sexton's Cottage

We were fortunate to have Diane Turner and her family as tenants for the third consecutive year. The absolute minimum maintenance needed for safety was done on the cottage. Many years have passed since we kept it at the required level of repair. Minor repairs were done to the interior and exterior. A basement leak was repaired, the bathroom redone and a window reframed.

Grounds

With the exception of snow removal, we have depended upon parishioners to maintain our grounds. We also had several Fine Option* volunteers working during 1997. They came as a result of Karen's creative efforts.

*The John Howard Society sponsors individuals who cannot pay fines exacted by the courts and who opt to volunteer their time to work off the fine.

Special Thanks

Cynthia Watts returned to Australia in October. She took her janitorial responsibilities very seriously and is missed. Cynthia's spiritual devotion to duty came naturally. Her work in the Parish buildings was deeply important. Vaila Mowat put her hand to creating small garden oases. Tom Gray volunteered to cut grass, including the challenge of the Little Dutch Church graveyard. To the huge number of other unnamed volunteers, a hearty thanks for your selfless work. The role of Hall Manager is unique and very diverse. Karen is one of those willing workers who only seem to be noticed by their absence. Finance Committee

The Finance Committee was struck in June, 1997 with the following membership: Mary Martin (chair), John Hammond, Michael Johnston (treasurer), Janet Ross (envelope secretary), Craig Savoury, Jim Snyder and, of course, the rector.

The Committee's most exacting task was the monitoring and reporting of expenses and revenues. During the course of the year, new reporting formats were adopted in an attempt to make monthly statements more user friendly. More work remains to be done on this front.

Another innovation was a change in the way weekly offerings are counted. Instead of expecting two or three parishioners to devote each Sunday afternoon to this job, the Finance Committee recruited six teams of two. Each team counts the offerings for one month twice a year. John Hammond is doing yeoman service training and overseeing the teams. The teams are: Chris West and Ian Henderson, Terry McLaughlin

and John Swaine, Hugh and Helen Tilley, Rob and Mary Martin and Michal King and Martin Yeatman. Thanks from the Finance Committee to everyone.

And what a lot of counting there was! The financial statements for 1997 included in this report show a significant increase in offerings. This magnificent generosity on the part of parishioners enabled the parish to complete the year with a balanced budget, and to pay a portion of our 1997 allotment even though it was not budgeted. Truly we have learned as a parish that it is better to give than to receive.

The budget for 1998 was drafted by a committee consisting of the chairs of committees, the wardens and the rector. Their first step was to adopt the following principles:

- The budget will include our 1998 allotment payments to the Diocese.
- We will endeavour to present a balanced budget.

- Revenue and expense projections will be realistic.
- The budget will assume that there will be no solicitation of parishioners for specific purposes.

The draft budget recommended by the Finance Committee and the Parish Council is our best attempt at meeting these principles. The Committee has tried to anticipate questions that parishioners may have about individual line items in the budget and to provide relevant information in the notes appended to the budget.

Thanks to a hardworking and dedicated committeee and especially to Michael Johnston for his unstinting service as treasurer and to Janet Ross who has enthusiastically taken on the job of envelope secretary.

Reports of Committees

Saint George's Restoration porch were completed. In addition, a church

In 1997, dedicated volunteers and professionals continued to work on both fronts of the restoration: construction and fundraising. Restoration continues to takes place only when funds are in place, so the project will be debt free on completion.

Construction

Under the management of Jim MacLean, the church remained in use from Easter to Christmas while also moving from a bare-bones structure to a remarkable recreation of its former self. Historic fabric, including laths under the gallery, was saved wherever possible and expert carpenters and plasterers created indistinguishable replacements where the fire and water had done their worst. Fine art conservator Jennifer McLaughlin and her assistants restored most of the chancel mural during the second half of the year and a Parks Canada conservator restored the pulpit. A new hardwood floor was installed in the chancel and the stairs, doors and railings in the

new porch was designed and created to provide protection for the new north door and wheelchair access.

Fundraising

Although Campaign Director Linda Crockett continued to explore every possible source of funds, the campaign continues to suffer from the fact that most corporations do not give to churches. However, our existing supporters remained faithful and many new ones were added. Work continued on a number of fronts and a total of \$363,354 was raised during the year. In mid-year, a campaign was launched to obtain funding to restore the pews. Many parishioners bought pews, and among others, pews have been purchased in memory of architect Graham Duffus and former parishioner Sir Samuel Cunard. Fundraising efforts include the new challenge of a separate campaign to raise the \$350,000 needed to purchase a 2-manual tracker organ for the

church. The Parish Challenge sparked 11 enjoyable events which raised over \$7,000 which will be matched by an anonymous parishioner when the project ends February 28, 1998. The year ended with a heartfelt response to the Christmas Appeal by our 2,500-plus existing donors. So far they have sent \$30,000 to help complete the restoration. By the end of the year, the total raised for the project was \$4.1 million, of which \$1,133,028 came from private sources. All financial transactions for the project continued to be done by Assistant Treasurer Karen Wheeler, whose dedicated work is much appreciated.

The future

It seems safe to say that we are in the final phase of the restoration and it is the earnest hope of all those who give so much time to the restoration that the bulk of the work will be completed in 1998.

Little Dutch Church Management Committee

Throughout 1997, evensong was said or sung at the Little Dutch Church at 4:00 p.m. on Sundays. During the summer, the German-Canadian Association opened the church to visitors on Sunday afternoons. A concert series was held during the summer and several weddings and baptisms were solemnized in the church.

Many people help look after the little Dutch Church. Chris West has put stengthening members under most of the seats to stop them sagging, and has built a bookcase to hold hymn and prayerbooks. Elizabeth Henderson is covering the kneelers and Joan Dawson will repair the hymn and prayerbooks early in 1998.

In December, it was learned from the Historic Sites and Monuments Board of Canada that the Little Dutch Church has been designated a National Historic Site because of its importance to the early history of Halifax and in particular to the early history of German settlers in Canada.

Throughout the year, the Little Dutch Church Management Committee worked to plan the restoration of the foundations of the building. The German-Canadian Association was awarded an Infrastructure Works Grant of \$50,000

for this purpose and this was announced at an October 30 ceremony during which the church was packed with municipal and provincial politicians.

With the help of this grant, architect Gary Hanley finalized details of a complex project to raise the LDC and insert new concrete foundations under it. These foundations will be masked by brick facing, so there will be little difference in the appearance of the building. The Committee came up with the \$67,000 (including grants) to cover the cost of this project and

work is expected to take place in February and March of 1998. It must be complete by the end of March to qualify for the Infrastructure Works Grant.

There are other conservation challenges facing the committee, which will continue to work to raise the funds necessary to conserve the building.

Primate's World Relief and Development Fund

The Primate's World Relief and Development Fund, Canada's Anglican mission, supports a large number of development projects around the world as well as responding to emergencies and advocating against injustice.

Our envelope giving was down on last year's total, \$566.25 compared to \$788.37. Christmas cards however raised nearly twice as much, over \$700. Thanks to all of you who, despite increased demands within our parish, dug generously into your pockets for the benefit of others in need.

In 1977 the fund focussed, with the World Council of Churches, on the plight of refugees. Canada's stand against landmines has been a positive step towards enabling displaced people to return home. In view of the continuing crises in Burundi, Rwanda, Zaire, Nigeria and Colombia, to mention but a few, it was decided to make 1998 a second year "in Solidarity with Uprooted People". Please watch the hall bulletin board for updated information.

It is sometimes hard to identify with individual families in need halfway round the globe. In December, however Judy Mills brought the Gbarazia family, refugees from Nigeria, to Saint George's; this was a wonderful oppunity to experience the partnership which is

the motto of the PWRDF; we are glad to welcome them to the parish family. I am also glad to announce that Judy will be joining me as a parish representative for the coming year.

The floods and more recently the ice storm brought home to us that disaster can strike at anytime in any place, not everywhere however are people so able to respond as they are in Canada. As we are once again displaced from our church home during Lent, let us be particularly aware of those who for political or economic reasons are forced from their homes (not knowing when or if they will ever return). At communion we might bring them before God when we pray for peace,

and remember the Fund's work as missioniaries. Do not forget them at collection time. I still have a few envelope calendars left if you have not received one.

If you would like to know how the Funds money is spent I have details for 1996. I also have a 15 minute video about the PWRDF if you would like to borrow it. Please contact Lorna Wallace 423-8733.

I conclude with a message from Archbishop Michael Peers: "Spiritual and social issues are not alternatives. We are in for the long haul. The God who is revealed in Jesus Christ is a God whose love encompasses the whole of human existence and the

church's mission is to keep plugging away at the social and political issues precisely because they are, at a fundamental level, spiritual issues." Respectfully Submitted, Lorna Wallace.

Notes to 1998 Budget

- 1. A detailed explanation of the planned increase in offerings is included as a separate attachment.
- 2. In 1996 the hall rental was \$6,670. In 1997 it was \$545. The budget projects approximately the same income as 1997. A concerted effort by the Property Committee and the Hall Manager may serve to increase the income to its previous levels.
- 3. The rectory property has an outstanding receivable owed for 1997 in the amount of \$2,850. This amount is a result of arrears in 1997 that are being repaid at the rate of \$350 per month. The sexton's cottage is in arrears by \$500 that will be paid in January 1998.
- 4. The budget reflects \$0 for the audit costs to be paid during 1998. Due to the extremely tight operating budget for 1998, we must secure the services of a volunteer to conduct our audit. The Diocesan Canons specifically permit the use of a volunteer for this important task.
- 5. The budget for advertising covers only \$500 for Christmas and Easter. We will require volunteer assistance for all other promotional needs of the Parish.
- 6. The budget for the Youth Worker covers only 10 months of 1998, as it is anticipated that we will hire a youth worker as of March 1998. In addition the Spiritual Development Committee and Pastoral Care Committee have both made a committment to seek external funds to further offset the costs of this much needed ministry.
- 7. The management fees for the Hall Manager and the Janitor do not reflect any change for 1998. It is intended that the Church will be cleaned by volunteers as a cost-saving measure. The job description for the Janitor will be changed to reflect the elimination of the duties of cleaning the Church.

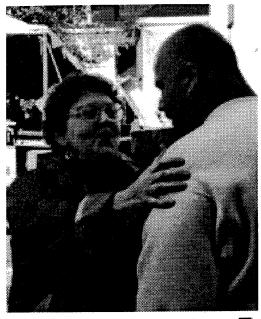

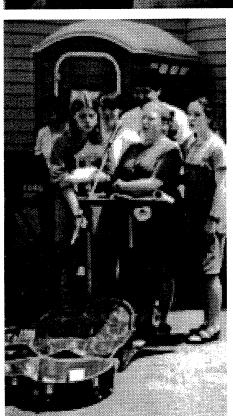
