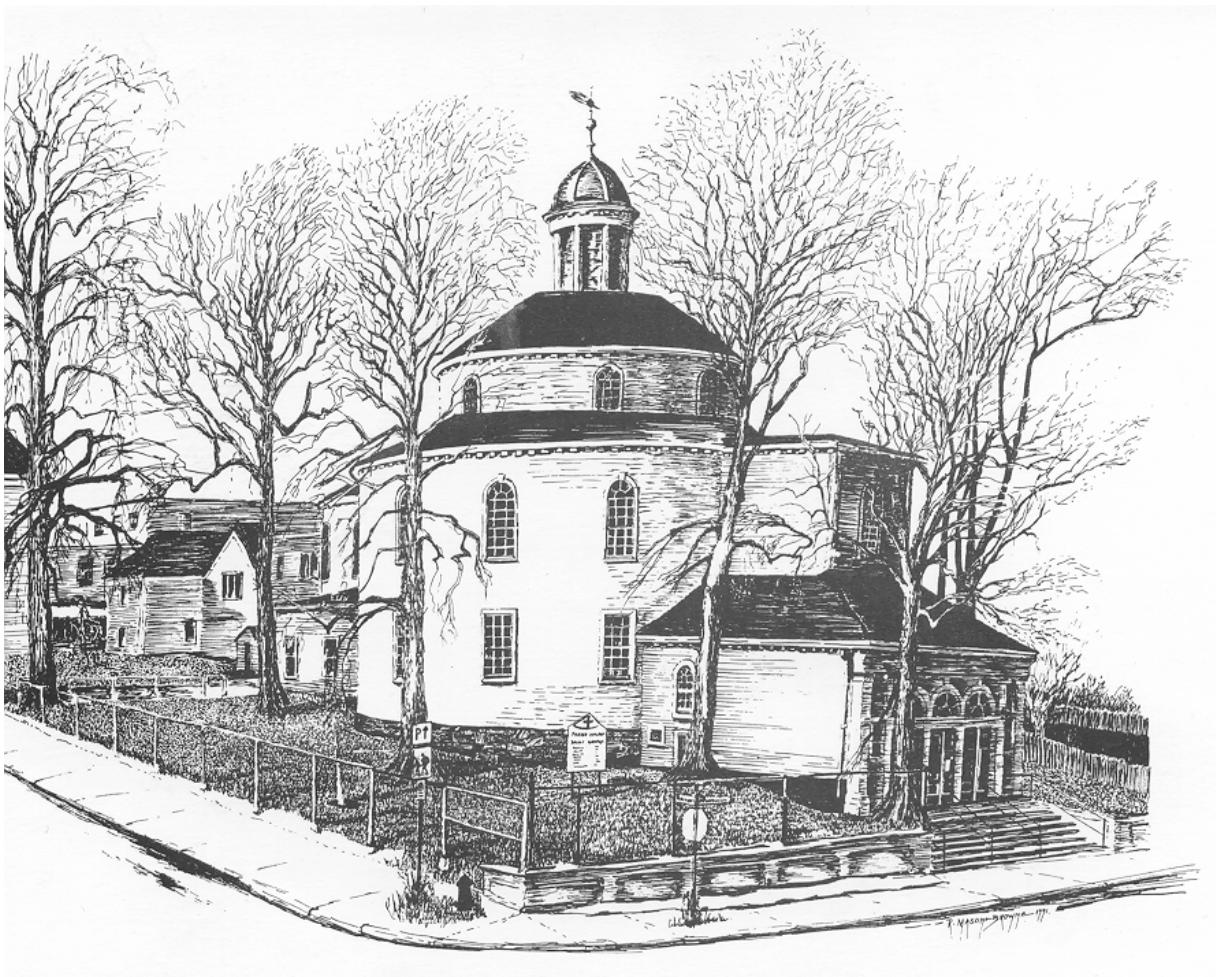

Parish of St. George Minutes of the Annual Meeting 2 March, 2008

The meeting convened at 1.08pm. The Rector acted as Chair. About 70 parishioners attended.

1. Opening Prayer.

Father Westhaver opened in prayer.

- 2/3. Minutes of the Annual Meeting of February 11, 2007 and Business arising from these Minutes.

No business arising from the minutes. Approval moved by Patricia Martinson, seconded by Aniko Lewton-Brain. Approved unanimously.

4. Correspondence.

Regrets were received from Andrew Thorne, Michal King and Martin Yeatman.

5. Financial Statements for 2007

Mary Hills pointed to the following:

- a. There is a surplus of income over expenditure for 2007 of \$13,871
- b. On p46 under income and expenses, the Yard Sale proceeds are not stated as a separate item but included under Special Events
- c. On p50 the items 'Preservation ST Fund' and 'Chandelier Fund' were pointed out as items of special interest

Approval of the statement moved by Mary Hills, seconded by Rob Martin. Discussion followed:

- a. Jim Brown requested clarification regarding the uses of the Preservation ST Fund. This consist of 15% of the profit from the annual Yard Sale, intended to build up as a fund to be applied to (as yet) unspecified projects.

- b. Rob Martin reported that the Checklist of Auditors had been completed and indicated satisfactory performance

c. Jim Brown wanted the checklist included in the Annual Report, and Father Westhaver indicated that due to time constraints this had not been possible this year. It is available for review.

d. Mary Hills thanked Jan Connors for her assistance with the duties of treasurer. Father Westhaver thanked Mary Hills for her work as treasurer. Both were applauded.

Motion to approve the financial statements received unanimous approval.

6. Insurance Reports for 2007.

Jens Jensen reported that the Diocese organizes insurance, resulting in a fall in premiums.

7. Rector's Report.

Father Westhaver emphasized that communal worship is our greatest gift, influencing our relation to each other and the community around us. He reflected on opportunities for us to build up community including the annual Yard Sale, small groups etc. He stated his sense of privilege at being the Rector and requested the Parish to exercise forbearance and patience with him as he pursues his duties among us. He thanked the Wardens. Susan Harris is finishing her term as Senior Warden, and was presented with a gift to thank her for her work amid general applause. Thanks also to Vaila Mowat for her many roles (parish library, the parish garden, altar guild etc) who was presented with a gift of thanks amid general applause. Thanks also conveyed to Paul Halley, in his role as music director.

8. Music Director's Report.

Paul Halley referred to p12-14 of the annual report. He appealed for the provision of pianofortes to assist him in choir rehearsals.

9. Wardens' Report.

Susan Harris offered thanks to those who supported the parish during the interregnum. She pointed affectionately to our diversity as a 'motley crew', and thanked the Rector for his 'patience and forbearance' as he enters the 'quirky world' of St George's. Thanks also to Paul Halley for his musical contributions.

She thanked her fellow wardens Jens Jensen and Craig Savoury for their assistance. Laura Bartlett proposed thanks to Susan Harris for her exemplary work as Warden; there was general applause.

10. Synod Delegates' Report.

Craig Savoury referred to p16-17 of the annual report.

11. Standing Committee Reports.

Finance Committee: Rob Martin had nothing to add. Father Westhaver thanked Rob Martin for his work as Committee Chair to general applause.

Spiritual Development: Gary McGonagill had nothing to add. Father Westhaver thanked Gary McGonagill for his work as Committee Chair to general applause.

Pastoral Ministry/Outreach: Nothing to add.

Stewardship: Nothing to add. Father Westhaver thanked Mary Martin for her work as Committee Chair to general applause.

Property: Jens Jensen referred to the points on p37-39 of the annual report. On the matter of the future of the hall, he added that a meeting had been held with Northwood Incorporated on 15 February 2008 to determine if they are interested in jointly developing a new church hall. If they are not interested then the Jost Report and earlier work will form the basis of future decisions regarding the hall. Whether it be by way of consideration of a joint venture with a party like Northwood, or the Jost plan, or earlier plans, the matter will come before a Parish meeting promptly, before summer if at all possible.

Jim Brown thanked Jens Jensen for his contributions and expressed a wish for active decisions on the future of the hall.

Patricia Martinson read a poem based on the 2001 annual general meeting, pointing to the repetition of discussions on the future of the hall over many years.

Father Westhaver thanked Jens Jensen, Heather Jensen, Betty Haigh and others involved with the repairs to the Rectory/Trinity House including Scott and Kim Connors and Craig Savoury to general applause.

Publicity: Taunya Dawson asked for assistance to distribute posters to publicize parish events.

A motion for approval of the reports was made by Jan Connors and seconded by Gertie Moulton. The motion to approve the reports was passed unanimously.

12. Proposed Budget for 2008.

Rob Martin commented that the budget is now a standard parish budget, since we are now fully staffed with a Rector and Music Director. Photocopies of the proposal were distributed to those dependent on a printed copy of the annual report, which inadvertently left the budget pages out. Total projected offerings have increased from \$279,556 (actual) in 2007 to \$288,913 (budget) in 2008, but most of this incorporates extra offerings from Trinity House, and offerings given and designated to support Fr Mercer's ministry. Questions:

- a. Stan Armstrong asked for clarification on the HST refund of \$10,000 which did not appear in 2007. This is due to delays in processing.
- b. Jim Brown asked why income from Trinity House is listed as offerings not rent. Father Westhaver pointed out that, due to zoning restrictions, we cannot act as landlords or collect rent. Those who occupy Trinity House do so as part of a Christian community, and make offerings to support the community, and assist the Parish through contribution of services of various types. They sign an

agreement with the Parish in which they agree that their occupancy is not a residential tenancy subject to the Residential Tenancies Act.

- c. John Hammond asked for clarification of the \$5000 given to musicians under the Music Program expenditures (p 53). Formerly, this was listed under music supplies but is now listed separate from the costs of sheet music for the sake of clarity. It is money paid for choral support on Sunday mornings.
- d. Bill Comerford asked for clarification on the budget related to the Deaf Ministry. Father Westhaver explained that proposed expenditures are similar to 2007 levels.

A motion for acceptance was proposed by Rob Martin and seconded by Jan Connors. The budget was approved unanimously.

13. Elections.

All those proposed for election on p44-45 of the Annual Report were elected unanimously without additional nominations. Father Westhaver thanked each individual who had been newly elected.

14. Other Business.

- a. Father Westhaver confirmed that the online annual reports had been well received and would continue to be offered. However, in response to concerns from those without electronic mail or internet access, printed reports would continue to be offered.
- b. Jim Brown appealed from more communications about the deliberations of Parish Council and the Wardens. Father Westhaver suggested that summaries could be printed in the bulletin to address this concern. Jim Brown thanked Laura Bartlett for the quality of the weekly parish bulletins.
- c. Father Westhaver thanked Karen Wheeler for organizing the potluck luncheon preceding the annual general meeting to general applause.

A motion to adjourn was made by Tracy Lenfesty and seconded by Rob Martin. Approved unanimously. Father Westhaver ended the meeting in prayer. The meeting adjourned at 3.00pm.

Rector's Report:

The state of the economy has been a matter of great concern for many people over the last six months. In Canada, the States, and around the world home-owners and people fearful of losing savings or a job, as well as politicians and economists, business leaders and journalists, have been thinking about the sources of the current crisis and debating proposed solutions. Before Christmas, the Archbishop of Canterbury spoke about the financial crisis as a reality check caused, in part, by unsustainable greed and which revealed the dangers, chasing after “fairy gold”, of spending what we do not have. In response to the Archbishop’s suggestion that an economic stimulus package was “a little bit like the addict returning to the drug,” the Prime Minister of the UK, Gordon Brown, turned to the parable of the Good Samaritan and said that the government could not “walk by on the other side when people are facing problems”. As well as highlighting the difficulty of interpreting the signs of the times, this exchange suggests the importance of thinking about economic questions in relation to the moral and spiritual issues which they raise. Questions about the economy are questions about communion, about inter-connectedness, about how we live together.

We can also think about parish life as a sort of economy. The word economy is derived from a Greek word which means household management. In this broader sense of management or organization, every community displays a sort of economy. This annual report describes the economy of this parish – the networks of exchange, the ministries and purposes, which make us a living community.

Economy also has another more strictly theological meaning. The “divine economy” describes all of God’s dealings with the world. In the Eastern tradition, a consideration of the divine economy is sometimes distinguished from theology. According to this division, “theology” contemplates the nature of God in Himself, the attributes and character of God, while “economy” describes how God acts in the world. The divine economy includes both how God created and sustains the world, and also especially how humankind is redeemed and saved by the work of Christ. Of course, this division is partly a theoretical one. What we know about God the Holy Trinity we know by the way in which the Father, the Son, and the Holy Spirit cooperate to redeem, transform, and sanctify humankind.

The divine economy and the economy of parish life are connected in important and essential ways. It is this divine economy, the coming down of the Lord Jesus Christ in the Incarnation, the transformation and sanctification of our lives and communities by the work of the Holy Spirit, which orders and makes sense of the ministries, organizations, and tasks described in this annual report. We cannot understand the economy of parish life without seeing it in relation to the divine economy. Our life as a community is a response which expresses and gives shape to the work of the Holy Spirit. The divine economy involves exchange – it is the work of grace to take what is human and enliven it with the divine life, to change water to wine, and make the human words of our prayers to sound in heaven: “He shall come down like rain upon the mown grass...in his time shall righteousness flourish” (Psalm 72.6-7). The divine economy is also purposeful – it manifests the Light of Christ and works for our salvation.

We can become clearer about our identity and goals if we consider the characteristics of the divine economy, the interchange or commerce between human and divine, which is expressed in worship and in the ministries which flow from that worship. Our life of worship offers a vision of abundance. The riches of worship, in both elaborate ceremony and simple prayer, in inspiring music or quiet reflection, express different aspects of the divine abundance. Worship both presents us with a vision of divine abundance, a kind of festival, and also invites us to seek more of these riches. Religious life is not a dreary obligation, but an invitation to a rich feast, not only the necessity of

doing what is required of us, but the blessing of discovering and showing the love of God for those in need and for one another.

The divine economy embodied in the worship of this parish is characterized by both realism and hope. On the one hand, our love of the darkness is put before us, and we are called in different ways through the year to turn to the light. On the other hand, we are invited to find a new perspective and real transformation. In the words of St Paul's prayer to the Father, "that according to the riches of his glory, he may grant you to be strengthened with power through his Spirit in your inner being...that you may be filled with all the fullness of God" (Ephesians 3.16). In the language of Epiphany, we pray that the light which was manifest in Christ may shine also in us.

Thinking about the activities and ministries of parish life as a living out of God's purposes for us can guide us as we seek to see the divine economy expressed in economy of parish life. According to this way of thinking, when we produce a budget we are not simply thinking about what we have to spend or how we can meet our obligations, but describing our vision for this parish. Attention to the fabric of the Round Church is not only necessary maintenance, but an expression of our will to provide a fit place for worship and a place of beauty that points to the delight of dwelling in the courts of the Lord. The commitment to supporting neighbourhood families at Christmas or supporting YouthNet year-round are not only about helping those in need, but about offering the love of God and responding to our vocation to be ministers in God's work of reconciliation and transformation.

Among its better fruits, the economic crisis has brought about a non-partisan appreciation about the importance of regulation. Politicians and commentators of all stripes seem to agree that economic systems cannot simply be left to happen. So it is in parish life. Things do not simply go along. There are always pressures, in the world and in ourselves, that would make things unravel. The *Rule of Life* on page 555 of *The Book of Common Prayer* invites us to consider and live out some of the disciplines that belong to commerce of parish life (if you don't have your own copy of the Prayer Book, this would be a good time to get one!). As we move toward Lent, each one of us is invited to renew our commitment to public worship and private prayer, to bringing the teaching and example of Christ into everyday life. One of the disciplines which belongs to the commerce of parish life is service to the community. As Christians we know that in attending to one another we are attending to coinage stamped with the divine image. Worship is a priority for us, but at St George's, we hold this alongside engagement in community, both the parish community and the neighbourhood community. This may be as simple as taking the time and risk to talk to one another at coffee hour or it may mean becoming more involved in some form of parish ministry. One of the great challenges for us is how we continue to support and care for one another.

This annual report and review is a picture of our common life, a picture of the divine economy worked out and expressed, however imperfectly, in the economy of parish life. I would like to thank each one of you for the many and different ways that you give yourselves to and support parish life, according to your different gifts and ministries. Let us pray that the abundance, realism and hope that are characteristic of the divine economy will continue to guide and inspire us here at St George's. -

Now unto him that is able to do exceeding abundantly above all that we ask or think, according to the power that worketh in us, Unto him be glory in the church by Christ Jesus throughout all ages, world without end. Amen. (Ephesians 3.20-21)

Wardens' Report

The year 2008 was relatively calm and straightforward in comparison to the two years preceding, during which the Parish was challenged to recruit a new Rector and Music Director and set up offices and administrative routines to support them. As if that were not enough, we had also risen to the tasks involved in major improvements to the Rectory to accommodate a rejuvenated Trinity House community and our Sexton's residence.

It is accurate to say that the outcome has been most satisfactory and that this year has seen great progress in our liturgies and music offerings, thanks to the inspiration and hard work of our Rector and Music Director, and Trinity House has been set on a firm footing. We seem to be operating well, to the extent that our greatest threat may be the risk of becoming complacent. We must never assume that things will work just fine without the direct involvement of every parishioner who is able to help in every way possible.

The details of the many aspects of Parish operations are set out in the reports in this Annual Report, and it is not necessary to summarize them here. It should be clear to all, upon reading them, that a large number of parishioners are heavily involved in the dozens of tasks that make us functional. Without their hard work and devotion, we would not have the quality or breadth of the Parish life we enjoy.

Our mission in the inner city has continued in a number of ways. Our support of YouthNet, Scouts, Soup Kitchen, family outreach, judicious use of the Rector's Discretionary Fund, and liaison with social agencies have been important to the community at both individual and organizational levels.

Music Director's Report

It has been 18 months since I took up my duties as Director of Music at St. George's on Sunday July 1st 2007. The choir now consists of 25 regular choristers of whom 6 also sing in the Chapel Choir at King's. Since we have enough chairs in the sanctuary to accommodate 24 singers it's probably just as well that on a typical Sunday one or two members of the choir are either sick, or in distant lands, sipping rum punches on a deserted beach (or both.) However, should a stunning tenor or bass want to join the ranks we'll definitely make room. We have changed our rehearsal nights from Thursdays to Wednesdays allowing those of us coming from King's Evensong an hour and a bit for sandwich chomping (courtesy of Janet Ross' sherry fund, the music budget and Paul Rogers' "Good Food Emporium" restaurant) instead of the half hour scramble we had last year. These sessions take place at the apartment of Nick Halley and Liz Kobes and involve the odd gin and tonic for the more mature chompers.

Speaking of Nick, I am eternally grateful for his presence here in Halifax. He plays for the Monday and Friday services at AST, he sings, conducts, and is starting to play the organ at the King's services, and he serves as my assistant at St. George's. As of January of this year, Nick no longer has to divide his Sunday morning time between King's and St. George's and is now with us every Sunday, not to mention every other choral service. Those of you who memorized the Music Director's Report from last year will recall the top two items on my wish list – another very good tenor and a very good organ scholar. Nick has more than fulfilled the first of those wishes and is well on the way to fulfilling the second, since he is currently practicing the organ like a fiend. He made his accompanying debut at our recent Nine Lessons & Carols service on the Tavener "God Is With Us" – an accompaniment that more than makes up in volume what it may lack in length. Nick's talents also extend to arm-waving, much to the satisfaction of those members of the choir who look at that kind of thing.

I want to publicly thank all the members of the St. George's Choir. Not only do they sing beautifully, but they are extraordinarily willing and committed (perhaps, in light of the time they spend at St. G's they should be committed) and they are a lot of fun. They also look pretty terrific since Laurelle LeVert and Sarah Stevenson went to a great deal of trouble organizing and labelling the cassocks and surplices, purchasing new ones, refitting old ones and generally cracking the whip on issues of laundry, hygiene and general decorum. This only resulted in the departure of a couple of choristers.

Aside from the normal round of Sunday 10:30 AM Choral Eucharists, the choir sang many additional services throughout the year, more perhaps than any other church choir in Canada, excepting the all-professional ones. Looking at this list, as well as the "Special Events" schedule attached will no doubt inspire you to offer your condolences and sympathy to any choir members you find wandering about. We are currently considering installing a few camp cots in the Music Office for the use of those singers who feel it is simply not worthwhile trying to get home between services.

Aniko Lewton-Brain with her lovely voice and violin has continued to lead the music in the non-choral Sunday Evensongs. During Advent and Lent she also puts together a quartet of voices for what are known as “Small Choir” Evensongs, which refers to their number, not their physical stature.

Additional Holy Week Services (not Eucharists)

I should mention at this point that Holy Week 2008 was, to say the least, a mixed blessing. Being one of the earliest Holy Weeks in living memory, it hit me like a ton of bricks. Trying to manage the music at both St. George's and King's (who inconveniently hold their Holy Week festivities at exactly the same time), made me sick – I got the flu. However, my son Nick Halley came for a visit, arriving on Good Friday. He took one look at me and decided to move to Halifax to make sure I never looked like that again. This is known in “1066” parlance as “a good thing.”

St. Michael and All Angels The Elora Festival Singers, an all-professional ensemble from Ontario and their conductor Noel Edison presented a workshop for young conductors in the afternoon and followed it up by singing gloriously for our Festal Eucharist that evening, which was very well attended. All they wanted in return (in lieu of a hefty fee) was to be fed and watered. Gary McGonagill and his cohorts put on an amazing spread in the Parish Hall between the workshop and service and Meg, Nick, Jonny and I hosted the group the following day out in Martin's River, with much boating, eating and drinking.

December 6th

A Concert of Music for Advent at St. Mary's, Crousetown. The choir went to Crousetown to give a concert and were rewarded with a sumptuous feast at the home of Father Crouse.

December 7th

Advent Lessons & Carols – attendance this year was up considerably.

December 28th

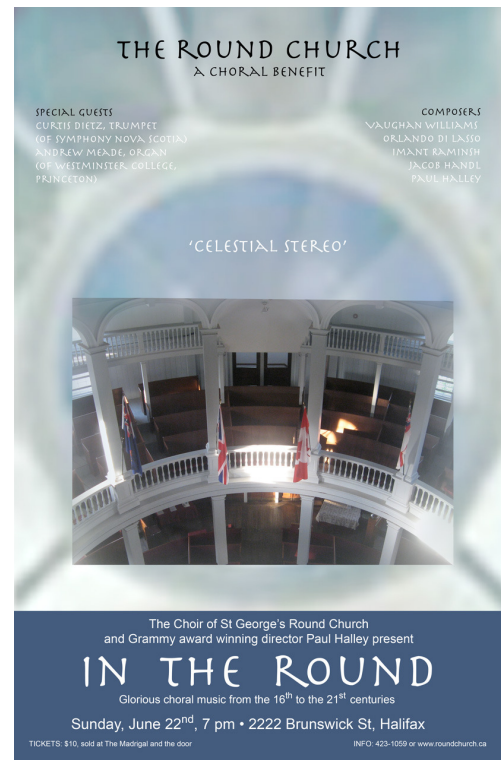

Summer Choir

For the second summer in a row we had a sizeable choir at each of our Sunday 10:30 AM services during the summer. This group consists of regular members of the St. George's Choir and guest singers from other churches who are officially "on vacation." More on the "wish list."

The Organ

We now have a new person in charge of organ maintenance and tuning. His name is Robert Hiller and he is one of the top people at Casavant. (*Orgues Létourneau* do not have maintenance people in the field.) Robert tunes, repairs and rebuilds many of the larger instruments in the Maritimes. Robert is often assisted by our own Brian Start when things get complicated.

Thanks to Sarah Stevenson and several other volunteers, the music library continues to become better organized and efficient. It has now been completely moved from the room behind the rear gallery in the church to the Music Office in the Parish Hall.

Publicity

Perhaps the most encouraging development for the music programme at St. George's this year has been the establishment of the St. George's Publicity Committee, chaired and hosted by Cheryl Bell. There is no doubt that the significant increase in numbers attending our special services and events is due to the work of Cheryl and her committee. They are a practical group applying sound New Testament theology in their efforts to get lights out from under bushels and dig up buried talents. I view them as critically important to the growth and therefore health of the parish.

Coming Up

The choir has been invited to participate in *The Three Churches Festival* in Mahone Bay this summer. They will present a concert on Friday August 21st and will repeat this concert at St. George's on Sunday August 23rd. They have also been asked to sing in the *Musique St. Bernard* series in September. Both of these invitations are signs of the growing reputation of the choir and are a tribute to the fine quality of their singing.

The choir will also present the second annual "In the Round" fundraising concert on Sunday June 21st at 7 PM. We are threatening to call this one "Round Two" unless someone comes up with something better.

Without doubt the most exciting new development on the Halifax music scene will be the establishment of a new **Men & Boys Choir** directed by Nick Halley. This programme is in the works at the moment requiring vast amounts of time and energy on Nick's part. More news will follow. It is very much hoped that this new group, pending the approval of the Parish Council, will be "in residence" at St. George's, taking advantage of the church's location in order to attract boys from the North End neighbourhood.

Also in the works is the wonderful possibility that *Tempest*, the early music ensemble directed by David Greenberg, might also become a group in residence, again, pending Parish Council approval. This project is in the earliest stages of discussion and I should probably keep it under my hat – or bushel – but I'm having difficulty containing myself. They are a first-class ensemble.

Wish List

- 1) Since the summer choir seems to have become something of a fixture, I would like to add to our "summer awareness" programme the possibility of having the church kept open during the day so that visitors can enjoy its fine architecture and history, learn more about its programmes, and possibly drop something in the collection box, once we've had one made. This would involve student "guides" and therefore grants etc. St. John's Lunenburg do this

quite successfully. Would it be worth talking to someone there or at least exploring this opportunity?

- 2) The choir needs a set of kneeler cushions – the wooden kneelers they have now are noisy, impractical and dangerous, and therefore only sporadically used.
- 3) Since we seem to be using the upstairs galleries more and more for singers and instrumentalists, I would like to consider removing a few pews upstairs in order to accommodate these musicians. I gather the fire regulations preclude our using all the pews upstairs in any case.
- 4) A new or rebuilt Parish Hall – I know people are working on this.
- 5) Pianos – we had none last year and that hasn't changed. Ideally one for the Parish hall and one (concert-worthy) for the church. I'll just keep putting this item on the annual wish list.

Finally

Many thanks to Andrea Lee for her great work on so many fronts in the Parish Office, and especially for her fine eye for detail which results in our handsome bulletins. Andrea and I will be working on further improvements in the bulletin layout.

I would particularly like to thank the rector, wardens and parishioners, and the "Friends of St. George's" who support the music programme at St. George's so willingly and with such generosity of spirit. It is a rare and fine thing you do.

Spiritual Development Committee

This was a year of transition for the Spiritual Development Committee. At the Parish Annual Meeting, Gary McGonagill concluded his term as Chairman and we are very grateful to him for the care and attention he gave to the spiritual life of the parish during his tenure. Neil Robertson stepped in to chair the Committee, but for personal reasons was unable to continue and resigned in the fall. Since then, the Rector, with the assistance of some long time members of the committee, has called meetings and made sure that the usual work of the committee continued. I have been asked to write the report of the committee for 2008.

At Epiphany, we gathered for a Choral Holy Communion, followed by a party at Trinity House. We are thankful to the members of Trinity House for welcoming the parish on this and several other occasions through the year.

In Lent, Sunday Evensong was led by a small choir brought together by Aniko Lewton-Brain and followed by a Series entitled "Christian Questions". The speakers were drawn from our congregation and the series considered the questions that trouble us on our Christian journey, including "Being truthful" (Dr. Wayne Hankey), "*The letter killeth but the spirit giveth life*" (Elizabeth Jones), "Confession and Self-Esteem" (Dr. Steven Burns), "Why strive for holiness?" (Jan Connors), and "Divisions in the Church: Is Christ divided?" (Michelle Wilband). In each case, the speaker gave a brief introduction which was followed by discussion. There was also a mid-week series, following a said Holy Communion Service on Tuesday evenings, offered by Father David Phillips, Rector of Petite Riviere and New Dublin. The title of the series was "Let our passions be for Christ: The passions of the soul adorned by grace". Father Phillips spoke about the passions of our souls identified in the early Church, their transformation by grace, and how they are a gift which may help us enter into God's rest. A discussion followed each talk.

Father Todd Meaker preached on Maundy Thursday and our Good Friday missioner, offering meditations about the Seven Last Words from the Cross, was Dr. John Baxter of the Dalhousie English Department. Dr. Gary McGonagill gave the meditation at the Easter Vigil.

In the week following Easter, we were delighted to welcome noted historian and author, William Dalrymple, to St. George's for an illustrated lecture on the spiritual life of the Middle East, which he described so evocatively in his book, "*From the Holy Mountain*". We heard about the rise and current fading away of Christian liturgical spirituality in the east. This lecture was followed by Compline in the candlelit church.

Duncan Neish, one of our postulants, did a tour of duty in Afghanistan this past year and in May spoke and showed slides to parishioners about his experiences in the war zone.

In October, we welcomed our new bishop suffragan, Bishop Ronald Cutler, to St. George's for his first visit. While here, he conducted the Rite of Confirmation, with 11 confirmed and 2 received from the Roman Catholic Church.

Also in October, Father Ron Evans, the Rector of the Anglican Parish in Ismir (the Biblical Smyrna) gave a talk following Sunday Evensong. Father Evans spoke about the life of a Christian priest in an officially secular but largely Muslim country.

In Advent, Father Westhaver conducted a Bible Study on some of the prophetic passages foretelling the coming of the Messiah in the Book of Isaiah, as a preparation for the coming of Christ at Christmas. This Bible Study took place at Trinity House and was attended by a number of its residents as well as other parishioners. The Revd Mark Harris, minister at Grace Chapel, was guest preacher on Advent III, and on Advent IV, a meditation by Father Christopher Snook was read. Advent Lessons and Carols took a slightly different form this year, with Scripture readings and music selected to accompany the Advent *O Antiphons*.

Cheryl Bell, our new Chair of the Publicity Committee, has drawn together a fine group to continue the work of getting out the word about St. George's. Due to the old "many hands make light work" adage, a great deal has been accomplished without anyone becoming over-burdened and with much good spirit. We are thankful for Cheryl's able leadership of this important committee. Publicity efforts this past year have resulted in some very well attended services and concerts, and a number of new people have joined our congregation.

I could not conclude this report without a sincere word of thanks to Father Westhaver and to Paul Halley. Both show a sensitive faithful and loving attention to the liturgy and music of our parish. The daily, weekly and yearly round of observances in the Book of Common Prayer take place at St. George's as they do almost nowhere else. This makes the Rector's life more challenging but also keeps him and us deeply grounded in the worship which is then expressed in the outreach and other activities of our parish, the love of friend and neighbour to which we are called. The music of our liturgy is extraordinary, sublime really. The liturgy and music are entwined as one offering of worship to Almighty God. Paul's willingness to offer extras – a Choral Evensong in the Christmas Season, in addition to Christmas Lessons and Carols, with a champagne reception afterwards hosted by the choir, the exuberance of the music at the major festivals, featuring our wonderful pipe organ, as well as brass, timpani and splendid choral music, and so much more – add to his workload, but also add greatly to the worship life of our parish.

Other individual reports (Sunday School, Servers, etc.) that fall under the purview of Spiritual Development follow this report.

However, if the mistake in the accounts for the month of January/February 2008 is put right, the two following amounts should be added to the credit side of the accounts: $\$89.97 + \$248.52 = \$338.49$. This shows that if the mistake had not been made, the accounts would read \$193.61 to the good.

One should however note that the allotment for the year of 2007 which is due in 2008 has not as yet been paid. It will be paid in January of 2009. Had it been paid in the 2008, it would again have put the accounts some \$250.00 or so in a deficit situation. Basically as we are not buying more flowers than before—indeed even less as the hanging baskets were not paid for this year by the Altar Guild as heretofore—I would have to say that, as the flowers are costing us more, we should cut back a little at Christmas and Easter. This will easily allow us to keep our accounts in the black.

Sunday School

Youth at St George's

YouthNet

When we think about YouthNet in 2007 this quote comes to mind: *"Continuity gives us roots; change gives us branches, letting us stretch and grow and reach new heights."* ~Pauline R. Kezer. Pauline describes much of what we experience here at YouthNet particularly in this past year.

In January 2008 Charys Payne was our Executive Director, Andrea Campbell our after-school coordinator and Laura Bartlett our lunch programme coordinator. There were a number of changes to the way programming was delivered in terms of time, ages and focus. Andrea introduced a new structure to after-school with a more defined focus every day. Although change is often resisted in the beginning, before spring things were running more smoothly and our average number of youth attending after-school programs hovered at 12. Soup Kitchen

I am sure that many people in our Parish do not know much about this outreach mission.

Some history:

In the early part of 1985, Bishop Peters came to St. George's for his annual visit and chaired the Parish Council meeting. At that time he suggested that we consider doing some outreach of some sort. The Pastoral Care Committee under the leadership of Cynthia Watts, called her members together the following week and began a brain storming session. Many ideas came forward but one very special from Mabel Wainwright (the mother of Michal King), who was 86 years old at the time. She thought it might be a good idea for us to serve a bowl of soup for 25 cents over the weekend to the clients who go to Hope Cottage Monday to Friday, and the money could go toward the church deficit. This would serve two purposes: feed the hungry and help the Parish – what a sweet lady!

Cynthia and I visited Hope Cottage many times to see if our idea was needed, we did lots of research and many meetings. It was a go – all we had to do was get approval from Parish Council which we did in October 1985. We then called a meeting of all the city's Anglican Churches to see how many were interested in helping us. At that meeting we gathered 28 teams consisting of 15 different churches and made up the first schedule with King's St. Andrew's Missionary Society taking the very first turn on November 9, 1985. Needless to say, we fine-tuned Mabel's idea, made it a free meal with help from other Parishes and not just soup. The food teams were expected to prepare a meal, hot or cold, for about 100 people and bring it to St. George's and serve it. Numbers grew to 150, plus, at times.

Examples of meals that we have served:

Roast Beef Dinner; Turkey Dinner; Roast Pork Dinner; Ham and Scallop Potatoes; Meat Loaf Meal; Corned Beef and Cabbage; Chicken/Rice Casserole; Hearty Beef Stew; Homemade Chunky Soup; Fish Chowder; All sorts of pastas; Cold Plate; and many more!

Bread, sweets, puddings, jello etc. are donated weekly.

Volunteers:

We presently have a volunteer list made up of 6 groups of 4 people each and they are expected to come once every 6 weeks. **This is where you can come in, as we have some openings to fill.** Volunteers are expected to come at 3 pm to help set up and dress the tables. Doors open from 4pm-5:30pm and we begin to clean up at 5:15pm and most Saturdays volunteers are out by 6pm.

So, 3 hours once every 6 weeks . . . try it, you will love it.

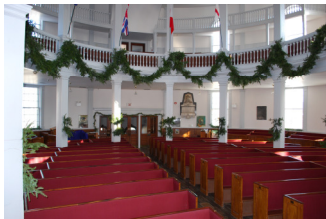

Stewardship Committee

In the fall of 2008, a few parishioners attended a conference sponsored by the Diocese called Shepherding an Effective Church in the 21st Century. It was a very positive experience and I think and hope that it has started some thought and discussion in our parish around the idea of stewardship. When we speak about stewardship within the context of the Church, we are speaking about the way in which we deal with all that we have - our time, our talents, our desires and our possessions. When we think about stewardship we must focus our thoughts inward as we ask ourselves what our priorities are, and then consider whether these priorities are reflected in the way that we use what we have been given. Deciding how to be good stewards of our resources requires careful thought and prayer as we discern what is reasonable to offer back to God in response to His goodness and mercy.

It is in this spirit that the parish sets its annual budget. We try as much as possible to reflect our priorities in the way we use the offerings received. Fundraising is different. It is very simply asking for money to meet the church's expenses, usually driven by a financial shortfall. A typical fundraising campaign occurs every October or November in our parish, when the parish executive look at the financial statements and discover that if parishioners continue to give at the current rate, we will have a shortfall at the end of December. A letter is written to parishioners, asking if they can increase their offerings in order that we can finish the year in the black rather than the red. This has become a yearly event in our parish. Every year most of us wish that this was not the case!

Although stewardship is not fundraising, there is obviously a connection between what the church receives as offerings and what we are able to spend as we try to love God and neighbour in our community. The Rector and Wardens with the Stewardship Committee decided that the offerings from special services such as Lessons and Carols and Choral Evensongs will be designated to special ministries both within and outside of our parish. For example, in November the offering from Choral Evensong on Remembrance Sunday was given to the Halifax Family Military Resource Centre. The offering from Lessons and Carols for Christmas was given to support the Music Programme. Recently, the offerings from Choral Evensong were given to the Deaf Ministry. We hope this will continue in 2009. We plan to keep parishioners informed by regular bulletin updates.

Many thanks to all who have come to meetings and brainstorming sessions to talk about stewardship, and those who have offered helpful advice - Father Westhaver, Kim Connors, Andrea Lee, Evelyn Mann, Mary Hills, Susan Harris, Jan Connors, and others. There will be more meetings this year; please let us know if you would like to join us, or if you have any questions about stewardship.

Finance Committee

The Parish's Finance Committee has recently been repopulated after a period of inactivity due to lack of volunteers to fill its positions. We now have Donald Wright, John Hammond and Dan Sargeant (Chair) on the Committee and we are getting organized and developing our agenda for the coming year. My thanks to Don and John for their able assistance. As was reported last year, there is much overlap between the Finance Committee and the Budget Committee. The budget has been the bulk of our activity thus far since we came together.

Budget

For FY 2008 the Parish's revenues fell short of targets while its expenses exceeded budgeted figures, for an approximate overall shortfall from budget of \$17,000. Given the financial uncertainties we have all been dealing with in '08 and now '09, this variance has been closely analyzed in the process of preparing the 2009 budget in an effort to avoid a repetition this year. The Budget Committee has been especially aware of possible revenue and expense management challenges for this year. The general theme in our discussions was one of: where and how can we increase, or at least maintain, our revenues while scrutinizing every expense item with an eye to wringing out every possible reasonable reduction. The Parish must recognize that to maintain current levels of service in all its endeavours, extra efforts will be necessary this year to strengthen our income. An increase in General Offerings of roughly \$10,000 over last year's actual will be necessary to break even in 2009. Details on the above are further available in the Treasurer's Report and the 2009 Budget, as presented.

2009

Ongoing discussions are under way with the Diocese with regard to our allotment. This is a natural and regular activity given the constantly evolving makeup of our revenue and expense mix as reported in the parochial returns. The actual amount of our allotment for 2009 will be solidified shortly.

The Finance Committee, being new in its membership, will immediately be bringing itself up to speed on Church financial and administrative issues and procedures. The most immediate item will be to ensure a fair audit of the 2008 results, within Diocesan guidelines. From there we intend to meet with various stakeholders in an effort to review some procedures where it may be helpful to do so.

Finally, having had a brief 6-week assignment as temporary Treasurer this past fall I have a full appreciation for the challenges and work necessary to fill that position. On behalf of all of us I would like to thank and commend Mary Hills for her services in the Treasurer position.

Property Committee

The year 2008 was a relatively quiet year concerning property matters, with some exceptions. Highlights, together with some brief information on the direction forward, include the following:

1. Security concerns were made manifest as we experienced a robbery at the church in January, in which some items and cash were taken from the Vestry. Replacement of them has

proceeded, and we do have coverage from our insurance to offset the loss over deductible. We have strengthened physical security of donations by installing a good strongbox. A new alarm system has been installed.

2. The church required repair and upkeep in mechanical systems and replacement of some deteriorated eaves fascia. Looking forward for the next several years, we should expect to see a round of replacement of mechanical equipment, since pumps and motors were all installed as new fixtures following the fire in 1994 and thus many will come to the end of their service life in the next few years. With the rising cost of furnace oil, attention in the near future should be paid to the ways and means of improving the energy efficiency of the building, without forgetting the need to continue to strive to improve upon the controlling of the heating system so that adequate comfort can be provided in the cold season.
3. The Little Dutch Church required little maintenance, and that which was performed was by volunteer effort.
4. The Rectory required only minor repairs, following the major upgrades in 2007. The building is in good structural condition, with the roof being replaced in the last few years, wiring and plumbing essentially up to date, and the interior being in reasonably good condition. For the future, the shabby exterior, including siding, trim, doors and windows, needs attention urgently.
5. The hall continues to be in need of frequent attention to its heating system, which is an awkward hybrid of two furnaces. A number of repairs and maintenance efforts during the year kept the hall operational, and much could of course be done in addition. However, only minimal, necessary maintenance of the building will be done in the future, as the Parish has determined to see it replaced in conjunction with a development which was much discussed during the year.

Specifically, a development concept was developed in concert with a private developer, which would see a multi-storey residential building erected with frontage on Maitland Street. Part of the financial agreement with the developer would see a new hall constructed (the existing hall would be demolished) with the cost of doing so paid by the ground rent paid by the developer for the area of the residential building. As the year closed, the Parish had been presented with the pros and cons of two options: renovation of the existing hall, versus the concept noted. A Parish advisory vote resulted in two thirds of those voting in favour of the new development concept, and Parish Council is moving forward in that direction. The concept requires an intensive attention to the details, which were beginning to be negotiated with the developer in the new year. As it stood at the end of 2008, the approval to proceed is an approval in principle, and the arrangement is not a sure thing until all details are settled. Both parties have the option of withdrawal from the negotiations if either of their respective expectations cannot be realized as the plan is detailed.

6. Considerable credit for the upkeep of the church properties must go to numerous volunteers who keep the premises orderly and who take on a number of maintenance tasks to supplement that done by paid help—gardening, painting, carpentry, adjusting heating controls, and cleaning. Without their attention, the premises would certainly be less attractive and useful than they are.

Administration Committee

The duties required of an Administration Committee in the Diocesan Canons are executed by two groups at St George's. The Finance & Budget committees look after the financial welfare of the parish, and the day-to-day activities of the office are handled by the Administration Committee. This year saw two major changes in the office. In January, the parish telecommunications (phone lines, internet service and website) were moved to Aliant, and YouthNet took on their own account with Eastlink. This meant a change in the parish email address, and a 150% increase in web space. This increased web capacity means that there is more room for development of our website and large documents such as the Annual Report can be added without having to delete photos and other material.

In August, Andrea Lee was our temporary office manager while Laura Bartlett was Acting Director of YouthNet after Charys Payne's resignation. In September, Laura moved full-time to YouthNet after 4 ½ years in the Parish Office and Andrea took on the duties of Parish Administrator. Laura was a tremendous asset to the parish. She has a wonderful gift for working with the many people in need who come to St George's looking for help. We know YouthNet will benefit greatly from her pastoral talents and we wish her well in her new, full-time position there. Parishioners regularly see Andrea's work in the form of the weekly bulletin, but like Laura before her, much of what she does for the parish is unseen. She is the only parish staff member who keeps regular hours in the building. She handles the incoming calls and emails to the parish and thus is often the first point of contact for those wishing to speak with our Rector or Music Director; hoping to attend a service and looking for more information; interested in the history of the Parish and church building; looking for assistance from our outreach funds; seeking to be married at St George's; to rent our space for a concert of their own; or to get in touch with YouthNet, and any other number of requests. She is often the person who communicates various areas of business on behalf of the property committee, and is the primary contact for trades people making service calls to fix leaky water heaters, cantankerous furnaces, obstreperous photocopiers etc. Andrea has recruited volunteers from time to time, to help with particular tasks in the office such as copying and folding Christmas bulletins, stuffing envelopes and organizing various non-confidential files. She would be happy to speak with any interested volunteers. Andrea works closely with Father Westhaver and Father Mercer, and alongside the Wardens and treasurer. Certain individuals such as Susan Harris, Sarah Stevenson, Jan Connors, and a few others, are helpful resources in matters of parish administration. The parish office is an important part of our ministry to God and neighbour and without the presence and efficiency of our parish administrator, the day to day running of the parish would be impossible.

The format and personnel of the Administration Committee will be reviewed in the coming year to better address the current needs.

Acquisitions: The year has been quiet on the Archives front. There have been no major additions to the Parish held collection. Planning should take place for active acquisition - that is the commitment from different parish groups to deposit representative items and essential historical records in the archives collection. Some thought should also be given to para-parish groups, such as YouthNet, the Scout and Guide organizations, the Soup Kitchen and others.

Storage: We have acquired a fireproof filing cabinet which will allow safer storage of records. For standard sized documents, this should hold the present in-house collection. There is no provision as yet for safe storage of our large format materials. In the new year the holdings will be sorted and stored as space and conditions allow.

Issues: In this coming year supplies of acid-free and buffered archival quality folders and portfolio materials will have to be made. There will likely be required additional fire-proof cabinets, both for large format material and for transferred records from the active parish files.

Permanent space needs to be allocated which allows only restricted access to the storage cabinets, storage of archival handling materials, and workspace for both those working with the collection and researchers. The required space would be 75-100 square feet. This would allow the space for two standard fire-proof file cabinets, a larger format cabinet which could also hold archival work materials and a small table to be used by both archive workers and researchers.

It is important that some discussion be taken in parish administration for the handling of digital and electronic records. Much vital correspondence and other operational records are held in

only electronic formats. We do not have an archival quality means of capturing these records for long term storage and reference.

Of interest: Among the requests for information handled over the past year was one concerning the use and influence of German music in the original and second St. George's churches. This German academic was in correspondence with the Parish in the latter part of the year and also made a visit to both churches, attending the celebration of the Epiphany.

I am especially grateful to Andrea Lee for handling primary requests and managing the on-site daytime requirements of this work.

Parish Gardens

In the fall of 2007, some new tulips were planted in one area of the garden, and these duly came up in the spring of 2008 and became ornaments for our altar. We also had bouquets from our naturalized daffodils. As it seemed to me that the time had come to add to our daffodil numbers, 50 new bulbs were bought and planted this fall. Then Mary Hills and I donated a collection of tulips to the number of about 150. Just as I had finished planting these, Edmonds told me that they had a lot of tulips left over and would like to plant some of them at St. George's so I pointed out the few areas not yet 'tulipified' and they planted I don't know how many more. We should have a great burst of flowers with which to beautify our church in the spring of 2009.

I have also planted a series of perennial geranium plants in the front plot, and hope that we shall get some colour from them in succeeding years. Also two new lilac plants have been acquired and planted along the side of the church. They will take some time to mature but are supposed to bear flowers not only in the spring, but at other times too. I also intend to buy a white lilac in the spring to keep them company. The extra female holly plant acquired in the Christmas of 2007 has not been very successful (I admit I did not give it enough water over the winter) and will be replaced in the spring with one of the 2008 Christmas holly plants.

We have been fortunate in having some volunteers come to help us in the garden this year. First of all, Edmonds are always very good to us when it comes to tasks I cannot perform. This year they cut back one of our lilacs which was growing all its flowers out of reach – altogether out of control. They also planted the last year's holly for me, and best of all, they took over the cutting of the hedge! Hurrah! This says nothing about all the help they give to the parish through the year by cutting the grass. Besides their help, we benefited this year from the help offered by the United Way, and also HRM. These volunteers spent a busy morning with me 1) taking apart the compost heap (a new one will have to be devised in the spring), 2) digging out the plot under the kitchen window of Trinity House and planting the daffodils, 3) digging three holes for the new lilac plants, 4) Spreading earth over an area beside the parking lot which has previously been rocky and difficult to keep in turf. For YouthNet, they also made a path through to the schoolyard from our parking

lot. This was where most of the earth came from, but composted sheep manure was added to it. It will need to be seeded in the spring. The parish, I should add, helped by paying for composted sheep and cow manure, and new topsoil.

Many thanks for all the help. YouthNet had a splendid year with their part of the garden, and successfully produced a good crop of food.

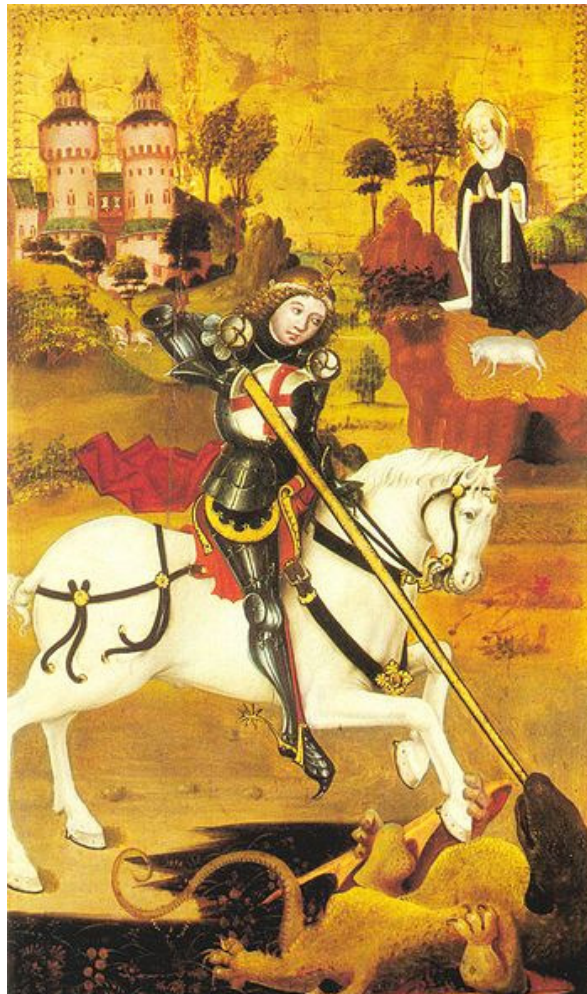
